Committee on Appropriations.

After consideration on the merits, the Committee recommends the following:

SB18-086 be amended as follows, and as so amended, be referred to the Committee of the Whole with favorable recommendation:

1 Amend printed bill, page 10, strike line 21 and substitute "(2)(1), and (4)
2 as follows:".

3 Page 11, after line 22 insert:

4 "(4) THE DEPARTMENT OF HIGHER EDUCATION SHALL ALLOCATE
5 TO THE GOVERNING BOARDS OF THE INSTITUTIONS OF HIGHER EDUCATION
6 PARTICIPATING IN ACTIVITIES RELATED TO CYBERSECURITY AND
7 DISTRIBUTED LEDGER TECHNOLOGIES, SUCH AS BLOCKCHAINS, MONEY
8 APPROPRIATED TO THE DEPARTMENT OF HIGHER EDUCATION BY THE
9 GENERAL ASSEMBLY FOR FISCAL YEAR 2018-19 AND FOR EACH FISCAL
10 YEAR THEREAFTER."

11 Page 13, after line 8 insert:

12 "SECTION 7. In Colorado Revised Statutes, 23-18-308, **amend**
13 (1) as follows:

14 **23-18-308. Fee-for-service contracts - limited purpose.**

15 (1) Subject to available appropriations, the department shall enter into a
16 fee-for-service ~~contract~~ CONTRACTS for the following ~~purpose~~ PURPOSES:

17 (a) The creation of career pathways for students pursuant to
18 sections 23-60-109 and 24-46.3-104; ~~C.R.S.~~ and

19 (b) The inclusive higher education pilot program pursuant to
20 section 23-75-104; AND

21 (c) CYBERSECURITY AND DISTRIBUTED LEDGER TECHNOLOGIES,

1 SUCH AS BLOCKCHAINS, AS SET FORTH IN SECTIONS 24-33.5-1904 AND
2 24-33.5-1905.

3 **SECTION 8. Appropriation.** For the 2018-19 state fiscal year,
4 \$5,000,000 is appropriated to the office of the governor for use by the
5 office of information technology. This appropriation is from the general
6 fund and is based on an assumption that the office of information
7 technology will require an additional 1.0 FTE. To implement this act, the
8 office of information technology may use this appropriation for security
9 governance.

10 (2) For the 2018-19 state fiscal year, \$4,800,000 is appropriated
11 to the department of higher education. This appropriation is from the
12 general fund. To implement this act, the department may use this
13 appropriation for the college opportunity fund program to be used for
14 limited purpose fee-for-service contracts with state institutions.

15 (3) For the 2018-19 state fiscal year, \$4,800,000 is appropriated
16 to the department of higher education. This appropriation is from
17 reappropriated funds received from the limited purpose fee-for-service
18 contracts with state institutions under subsection (2) of this section. To
19 implement this act, the department may use this appropriation as follows:
