5 **18-119 - repeal.** (1) PURSUANT TO SECTION 2-2-703, THE FOLLOWING
6 STATUTORY APPROPRIATIONS ARE MADE IN ORDER TO IMPLEMENT SENATE
7 BILL 18-119, ENACTED IN 2018:

8 (a) FOR THE 2018-19 STATE FISCAL YEAR, TWENTY-TWO
9 THOUSAND SEVENTY-TWO DOLLARS IS APPROPRIATED TO THE
10 DEPARTMENT FROM THE GENERAL FUND;

11 (b) FOR THE 2019-20 STATE FISCAL YEAR, THIRTY-FOUR
12 THOUSAND SIX HUNDRED SEVENTY-SEVEN DOLLARS IS APPROPRIATED TO
13 THE DEPARTMENT FROM THE GENERAL FUND;

14 (c) FOR THE 2020-21 STATE FISCAL YEAR, THIRTY-NINE THOUSAND
15 THREE HUNDRED THIRTY-FOUR DOLLARS IS APPROPRIATED TO THE
16 DEPARTMENT FROM THE GENERAL FUND;

17 (d) FOR THE 2021-22 STATE FISCAL YEAR, THIRTY-NINE THOUSAND
18 THREE HUNDRED THIRTY-FOUR DOLLARS IS APPROPRIATED TO THE
19 DEPARTMENT FROM THE GENERAL FUND; AND

20 (e) FOR THE 2022-23 STATE FISCAL YEAR, THIRTY-NINE THOUSAND
21 THREE HUNDRED THIRTY-FOUR DOLLARS IS APPROPRIATED TO THE
22 DEPARTMENT FROM THE GENERAL FUND.

- 1 (2) THIS SECTION IS REPEALED, EFFECTIVE JULY 1, 2023."
- 2 Renumber succeeding section accordingly.
- 3 Page 1, line 101, strike "MINOR." and substitute "MINOR, AND, IN
- 4 CONNECTION THEREWITH, MAKING AN APPROPRIATION."
