HB19-1149 be amended as follows, and as so amended, be referred to the Committee on Appropriations with favorable recommendation:

- 1 Amend printed bill, page 2, line 5, strike "MARCH 31, 2020," and
2 substitute "JUNE 30, 2020,".
- 3 Page 2, lines 5 and 6, strike "THE AGE OF DELINQUENCY TASK FORCE OF".
- 4 Page 2, lines 8 and 9, strike "MAKE RECOMMENDATIONS TO THE
5 COMMISSION, WHO SHALL, IN TURN,".
- 6 Page 2, line 11, strike "TASK FORCE" and substitute "COMMISSION".
- 7 Page 2, line 13, strike "TASK FORCE" and substitute "COMMISSION".
- 8 Page 2, line 17, strike "DATA MUST INCLUDE:" and substitute "DATA, AS
9 AVAILABLE, MUST INCLUDE THE FOLLOWING:".
- 10 Page 3, line 7, strike "NOT;" and substitute "NOT IN COMPLETING HIS OR
11 HER SENTENCE;".
- 12 Page 3, strike lines 8 and 9 and substitute:
13 "(G) ANY PRIOR SERVICES PROVIDED THROUGH CRIMINAL AND
14 JUVENILE JUSTICE INVOLVEMENT; AND".
- 15 Page 3, line 10, strike "TASK FORCE" and substitute "COMMISSION".

- 1 Page 3, lines 17 and 18, strike "GROWING AND THAT THEY ARE LESS
- 2 CAPABLE OF REASONED THINKING IN CHARGED SETTINGS," and substitute
- 3 "DEVELOPING AND HAVE DIFFICULTY WITH QUALITATIVE
- 4 DECISION-MAKING, AND THEY ARE".

- 5 Page 3, line 19, after "THAN" insert "OLDER".

- 6 Page 3, lines 23 and 24, strike "TO THE COMMISSION".

- 7 Page 4, line 2, strike "MARCH 31, 2020," and substitute "JUNE 30, 2020,".

- 8 Strike "TWENTY-ONE" and substitute "TWENTY-FIVE" on: **Page 2**, line 17;
- 9 **Page 3**, lines 13 and 16.

- 10 Strike "EMERGING" and substitute "YOUNG" on: **Page 3**, lines 12, 15, 23,
- 11 and 25.
