After consideration on the merits, the Committee recommends the following:

HB19-1167 be amended as follows, and as so amended, be referred to the Committee on Finance with favorable recommendation:

- 1 Amend printed bill, page 9, strike lines 12 through 27.
- 2 Strike pages 10 and 11.
- 3 Page 12, strike lines 1 through 16.
- 4 Renumber succeeding subsections accordingly.
- 5 Page 12, line 27, strike "(10)" and substitute "(9)".
- 6 Page 13, line 2, strike "(10)(b)," and substitute "(9)(b),".
- 7 Page 14, strike lines 18 through 25 and substitute:
  - 8 "(11) THE OPERATOR OF A REMOTE NOTARIZATION SYSTEM OR
  - 9 OTHER PROVIDER OF TECHNOLOGY OR STORAGE FOR AN AUDIO-VIDEO
  - 10 RECORDING CREATED UNDER SUBSECTION (9) OF THIS SECTION SHALL BE
  - 11 DEEMED TO BE TRANSACTING BUSINESS IN THIS STATE AND, IF A FOREIGN
  - 12 ENTITY, SHALL APPOINT AND MAINTAIN A REGISTERED AGENT, IN
  - 13 ACCORDANCE WITH SECTION 7-90-701, WITH AUTHORITY TO ACCEPT
  - 14 SERVICE OF PROCESS IN CONNECTION WITH A CIVIL ACTION OR OTHER
  - 15 PROCEEDING THAT INVOLVES ISSUES RELATING TO THE AUDIO-VIDEO
  - 16 RECORDING."
- 17 Page 16, line 4, after "NOR" insert "THE OPERATOR OF".

1 Page 16, line 7, strike "(10)" and substitute "(9)".

2 Page 17, strike lines 14 through 22 and substitute "**applicability.** (1) This  
3 act takes effect January 1, 2021; except that, if a referendum petition is  
4 filed pursuant to section 1 (3) of article V of the state constitution against  
5 this act or an item, section, or part of this act within the ninety-day period  
6 after final adjournment of the general assembly, then the act, item,  
7 section, or part will not take effect unless approved by the people at the  
8 general election to be held in November 2020 and, in such case, will take  
9 effect January 1, 2021, or on the date of the official declaration of the  
10 vote thereon by the governor, whichever is later."
