Amend printed bill, page 3, strike lines 7 through 14 and substitute:
"SECTION 4. In Colorado Revised Statutes, add 17-18-127 as
follows:
17-18-127. Appropriation to comply with section 2-2-703 - S.B.
19-172 - repeal. (1) PURSUANT TO SECTION 2-2-703, THE FOLLOWING
STATUTORY APPROPRIATIONS ARE MADE IN ORDER TO IMPLEMENT SENATE
BILL 19-172, ENACTED IN 2019:
(a) For the 2019-20 state fiscal year, one hundred ten
THOUSAND SIX HUNDRED FIFTY-TWO DOLLARS IS APPROPRIATED FROM
THE CAPITAL CONSTRUCTION FUND CREATED IN SECTION 24-75-302 TO THE
CORRECTIONS EXPANSION RESERVE FUND CREATED IN SECTION 17-1-116.
(b) FOR THE 2020-21 STATE FISCAL YEAR, TWENTY-SIX THOUSAND
TWO HUNDRED TWENTY DOLLARS IS APPROPRIATED TO THE DEPARTMENT
FROM THE GENERAL FUND.
(c) For the 2021-22 state fiscal year, one thousand nine
HUNDRED TWO DOLLARS IS APPROPRIATED TO THE DEPARTMENT FROM THE
GENERAL FUND.
SECTION 5. In Colorado Revised Statutes, 24-75-302, add
(2)(gg) as follows:
24-75-302. Capital construction fund - capital assessment fees
- calculation - information technology capital account - repeal.
(2) The controller shall transfer a sum as specified in this subsection (2)

- from the general fund to the capital construction fund as money becomes
- 2 available in the general fund during the fiscal year beginning on July 1 of
- 3 the fiscal year in which the transfer is made. Transfers between funds
- 4 pursuant to this subsection (2) are not appropriations subject to the
 - limitations of section 24-75-201.1. The amounts transferred pursuant to
- 6 this subsection (2) are as follows:
- 7 (gg) FOR THE 2019-20 STATE FISCAL YEAR, ONE HUNDRED TEN
- 8 THOUSAND SIX HUNDRED FIFTY-TWO DOLLARS PURSUANT TO S.B. 19-172,
- 9 ENACTED IN 2019.".
- 10 Renumber succeeding sections accordingly.
- Page 1, line 103, strike "CONFINEMENT." and substitute "CONFINEMENT
- 12 AND MAKING AN APPROPRIATION.".
