After consideration on the merits, the Committee recommends the following:

HB20-1011 be amended as follows, and as so amended, be referred to the Committee on Appropriations with favorable recommendation:

- 1 Amend printed bill, page 2, strike lines 11 and 12.
- 2 Renumber succeeding subsections accordingly.
- 3 Page 3, line 7, strike "**campaign -**" and substitute "**activities -**".
- 4 Page 3, strike lines 8 through 16 and substitute "DEPARTMENT SHALL  
5 ENGAGE IN A GRASSROOTS EFFORT TO RAISE AWARENESS AND IMPLEMENT  
6 ACTIVITIES IN EACH COUNTY THAT SERVE AS A RESOURCE FOR ALL  
7 FAMILIES WITH PRESCHOOL-AGED CHILDREN AND THE EARLY CHILDHOOD  
8 CAREGIVERS IN THE STATE TO ENSURE THAT CURRENT AND PROSPECTIVE  
9 EARLY CHILDHOOD EDUCATION PROVIDERS ARE AWARE OF:".
- 10 Page 3, strike lines 22 through 27 and substitute:  
11 "(2) THE DEPARTMENT SHALL WORK COLLABORATIVELY WITH  
12 EARLY CHILDHOOD COUNCILS, FAMILY RESOURCE CENTERS, AS DEFINED IN  
13 SECTION 26-18-102, AND OTHER LOCAL PARTNERS AS NECESSARY AND  
14 APPROPRIATE TO IMPLEMENT THE PROVISIONS OF THIS SECTION.".
- 15 Page 4, strike lines 1 through 14.
- 16 Page 4, line 18, after "FOR" insert "CURRENT AND PROSPECTIVE".

- 1 Page 5, line 1, strike "THE" and substitute "AS RESOURCES ALLOW, THE".
- 2 Page 5, line 3, strike "an" and substitute "**a licensed**".
- 3 Page 5, line 4, strike "**center or preschool -**" and substitute "**program -**".
- 4 Page 5, line 6, strike "INSTRUCT" and substitute "INFORM".
- 5 Page 5, line 7, strike "ON:" and substitute "CONCERNING:".
- 6 Page 5, line 8, strike "CENTER OR PRESCHOOL;" and substitute "PROGRAM  
7 LICENSED PURSUANT TO PART 1 OF ARTICLE 6 OF THIS TITLE 26;".
- 8 Page 5, strike line 13 and substitute "PROGRAMS LICENSED PURSUANT TO  
9 PART 1 OF ARTICLE 6 OF THIS TITLE 26.".
- 10 Page 5, line 16, strike "THE" and substitute "AS RESOURCES ALLOW, THE".
- 11 Page 1, line 102, strike "ACT"." and substitute "**ACT" TO PROMOTE BEST  
12 PRACTICES IN EARLY CHILDHOOD EDUCATION WITH THE PURPOSE OF  
13 INCREASING THE AVAILABILITY OF QUALITY EARLY CHILDHOOD  
14 EDUCATION BY PERSONS KNOWLEDGEABLE OF THE LICENSING  
15 PARAMETERS FOR THE EARLY CHILDHOOD EDUCATION INDUSTRY."**
