HB20-1113 be amended as follows, and as so amended, be referred to the Committee on Appropriations with favorable recommendation:
Amend printed bill, page 2, strike lines 12 through 15 and substitute:
"27-71-102. Mental health education and suicide prevention
resources - directory created. (1) (a) No LATER THAN NOVEMBER 1,
2021, THE STATE DEPARTMENT SHALL CONTRACT WITH AN ORGANIZATION
TO CREATE AN ONLINE RESOURCE DIRECTORY FOR INDIVIDUALS SEEKING
BEHAVIORAL HEALTH SERVICES IN COLORADO, WHICH MUST INCLUDE THE
FOLLOWING RESOURCES:
(I) INFORMATION ABOUT THE BEHAVIORAL HEALTH CRISIS
RESPONSE SYSTEM CREATED PURSUANT TO SECTION 27-60-103;
(II) THE REFERRAL RESOURCES USED BY THE CONTRACTOR OF THE
TWENTY-FOUR-HOUR TELEPHONE CRISIS SERVICES PROVIDED PURSUANT
TO SECTION 27-60-103;
(III) THE PUBLIC-FACING COMPONENT OF THE BEHAVIORAL
HEALTH CAPACITY TRACKING SYSTEM CREATED PURSUANT TO SECTION
27-60-104.5;
(IV) BEHAVIORAL HEALTH PUBLIC AWARENESS CAMPAIGNS RUN
BY THE STATE OF COLORADO; AND
(V) Any other resources as determined by the state
DEPARTMENT.
(b) FOR EACH PROVIDER ADDED TO THE DIRECTORY PURSUANT TO
SUBSECTION (1)(a)(II), (1)(a)(III), OR (1)(a)(IV) OF THIS SECTION, THE
FOLLOWING INFORMATION SHALL BE INCLUDED, WHEN POSSIBLE:
(I) THE PROVIDER'S NAME, WEBSITE ADDRESS, AND TELEPHONE

- 1 NUMBER;
- 2 (II) THE TYPES OF TREATMENT OR SERVICES PROVIDED; AND
- 3 (III) LANGUAGES SERVED.
- 4 (2) THE ONLINE DIRECTORY SHALL BE AVAILABLE IN BOTH 5 ENGLISH AND SPANISH.
- 6 (3) THE STATE DEPARTMENT MAY SOLICIT, ACCEPT, AND EXPEND ANY GIFTS, GRANTS, OR DONATIONS FROM PRIVATE OR PUBLIC SOURCES TO
- 8 IMPLEMENT THE PROVISIONS OF THIS SECTION AND FOR THE
- 9 DEMOGRAPHIC-SPECIFIC, TARGETED, AND DESTIGMATIZED DIGITAL
- 10 MESSAGING DEVELOPED AND DISTRIBUTED PURSUANT TO SECTION
- 11 27-71-103, REGARDLESS OF WHETHER THE GIFT, GRANT, OR DONATION IS
- 12 PRESENTED IN A DIGITAL FORMAT.".

- 14 Page 4, strike lines 1 through 10.
- 15 Page 4, strike lines 11 through 18 and substitute:
- 16 "27-71-103. Request for proposal demographic-specific
- targeted messaging. (1) NO LATER THAN APRIL 1, 2021, THE STATE
- 18 DEPARTMENT SHALL ISSUE A REQUEST FOR PROPOSAL TO CONTRACT WITH
- 19 AN ORGANIZATION TO DEVELOP AND DISTRIBUTE DEMOGRAPHIC-SPECIFIC.
- 20 TARGETED, AND DESTIGMATIZED DIGITAL MESSAGING RELATED TO THE
- 21 ONLINE DIRECTORY CREATED PURSUANT TO SECTION 27-71-102.
- 22 (2) THE CONTRACTING ORGANIZATION SHALL CONDUCT INITIAL
- 23 RESEARCH TO UNDERSTAND AND IDENTIFY THE DEMOGRAPHICS WITH THE
- 24 HIGHEST BEHAVIORAL HEALTH NEEDS IN COLORADO.
- 25 (3) THE DEMOGRAPHIC-SPECIFIC, TARGETED, AND DESTIGMATIZED
- 26 DIGITAL MESSAGING DESCRIBED IN SUBSECTION (1) OF THIS SECTION MUST
- 27 BE DISTRIBUTED NO LATER THAN JANUARY 1, 2022.".
- 28 Page 1, line 102, strike "A WEBSITE" and substitute "AN ONLINE
- 29 DIRECTORY".
- Page 1, line 103, strike "AND INTERNET LINKS".
- Page 1, line 104, strike "IN EACH GEOGRAPHIC REGION".
