- 5 Page 14, strike line 19 and substitute "BUSINESSES AND HOW MUCH OF THE
- 6 ALLOCATION THE ELIGIBLE LOCAL GOVERNMENT USED FOR
- 7 ADMINISTRATIVE COSTS, DETAILING HOW THE MONEY FOR
- 8 ADMINISTRATIVE COSTS WAS SPENT.".
