After consideration on the merits, the Committee recommends the following:

HB21-1006 be amended as follows, and as so amended, be referred to the Committee on Appropriations with favorable recommendation:

- 1 Amend printed bill, page 3, line 15, strike "AND".
- 2 Page 3, line 20, strike "WORKWEEK." and substitute "WORKWEEK; AND".
- 3 Page 3, after line 20 insert:
  - 4 "(g) WHILE SCHOOL DISTRICTS ARE OPERATING ON A FOUR-DAY
  - 5 SCHOOL WEEK, SUPPLEMENTAL ENRICHMENT PROGRAMMING AND RELATED
  - 6 ENRICHMENT ACTIVITIES CAN HELP PROVIDE STUDENTS WITH THE
  - 7 SUPPORTS THEY NEED."
- 8 Page 4, line 25, after "RELATED" insert "ENRICHMENT ACTIVITIES AND".
- 9 Page 4, lines 25 and 26, strike "FULL-DAY KINDERGARTEN" and substitute
- 10 "PRESCHOOL".
- 11 Page 4, line 27, strike "AGE." and substitute "AGE AND WHO ATTEND A
- 12 PUBLIC SCHOOL THAT OPERATES ON A FOUR-DAY WEEK."
- 13 Page 5, line 4, after "ACADEMIC" insert "AND SOCIAL AND EMOTIONAL".
- 14 Page 5, line 7, after "ACADEMIC" insert "AND SOCIAL AND EMOTIONAL".
- 15 Page 5, line 12, strike "PROGRAMMING;" and substitute "PROGRAMMING

1 AND THE COSTS ASSOCIATED WITH PROVIDING TRANSPORTATION TO AND  
2 FROM PROGRAMMING;"

3 Page 5, line 18, strike "OR".

4 Page 5, after line 18 insert:

5 "(g) TO MAKE NEEDED ACCOMMODATIONS FOR STUDENTS WITH  
6 DISABILITIES; OR".

7 Reletter succeeding paragraph accordingly.

8 Page 5, line 21, after "SHALL" insert "IMPLEMENT AND" and strike  
9 "PROGRAM." and substitute "PROGRAM; EXCEPT THAT THE DEPARTMENT  
10 SHALL NOT IMPLEMENT OR ADMINISTER THE GRANT PROGRAM UNLESS THE  
11 GENERAL ASSEMBLY APPROPRIATES SUFFICIENT MONEY TO THE FUND FOR  
12 SUCH PURPOSES."

13 Page 5, lines 22 and 23, strike "BEGINNING IN THE 2021-22 STATE FISCAL  
14 YEAR,".

15 Page 5, strike line 27.

16 Page 6, strike line 1 and substitute:

17 "(4) PURSUANT TO ARTICLE 4 OF TITLE".

18 Page 6, line 22, strike "FULL-DAY KINDERGARTEN" and substitute  
19 "PRESCHOOL".

20 Page 6, line 23, strike "AGE; AND" and substitute "AGE AND WHO ATTEND  
21 A PUBLIC SCHOOL IN A SCHOOL DISTRICT THAT OPERATES ON A FOUR-DAY  
22 WEEK; AND".

23 Page 7, line 8, strike "AND".

24 Page 7, line 12, strike "22-104-104." and substitute "22-104-104; AND".

25 Page 7, after line 12 insert:

26 "(c) A DESCRIPTION OF HOW THE NEEDS OF STUDENTS WITH  
27 DISABILITIES WILL BE ADDRESSED AND ACCOMMODATED."



- 1 Page 8, strike line 19 and substitute "FEBRUARY 15 IN EACH FISCAL  
2 YEAR".
- 3 Page 8, line 20, strike "THEREAFTER".
- 4 Page 9, lines 10 and 11, strike "APRIL 1, 2022, AND ON OR BEFORE APRIL  
5 1 EACH YEAR THEREAFTER" and substitute "APRIL 1 IN EACH FISCAL YEAR  
6 IN WHICH A GRANT IS AWARDED".
- 7 Strike "EDUCATIONAL" and substitute "ENRICHMENT" on: **Page 3**, lines 11  
8 and 23; **Page 4**, line 24; **Page 5**, lines 3, 6, 12, 14, and 18; **Page 6**, lines  
9 15 and 20; **Page 8**, line 14; and **Page 9**, line 7.
- 10 Page 1, line 101, strike "EDUCATIONAL" and substitute "ENRICHMENT"
