After consideration on the merits, the Committee recommends the following:

HB21-1027 be amended as follows, and as so amended, be referred to the Committee on Finance with favorable recommendation:

1 Amend printed bill, page 2, line 2, strike "**repeal (7)**" and substitute  
2 "**amend** (2)(b)(III), (6)(a), and (7)".

3 Page 2, strike line 6 and substitute "**rules - definition - repeal. (2)** To  
4 sell and deliver an alcohol beverage or to allow a customer to remove an  
5 alcohol beverage from the licensed premises as either is authorized under  
6 subsection (1) of this section, the licensee must:

7 (b) Sell or deliver:

8 (III) No more than the following amounts of alcohol beverages  
9 per delivery or takeout order unless the governor has declared a disaster  
10 emergency under part 7 of article 33.5 of title 24:

11 (A) ~~Seven hundred fifty~~ ONE THOUSAND FIVE HUNDRED milliliters,  
12 approximately ~~26.4~~ 50.8 fluid ounces, of ~~spirituous liquors and~~ vinous  
13 liquors; and

14 (B) ~~Seventy-two~~ ONE HUNDRED FORTY-FOUR fluid ounces,  
15 approximately ~~two thousand forty-six~~ FOUR THOUSAND TWO HUNDRED  
16 FIFTY-NINE milliliters, of malt liquors, fermented malt beverages, and  
17 hard cider; AND

18 (C) ONE LITER, APPROXIMATELY 33.8 FLUID OUNCES, OF  
19 SPIRITUOUS LIQUORS.

20 (6) (a) (I) ~~As used in this section, "licensee" means a person~~  
21 ~~issued a license under~~ THIS SECTION AUTHORIZES A LICENSE HOLDER THAT  
22 IS ISSUED A LICENSE UNDER ONE OF THE FOLLOWING SECTIONS TO SELL AN  
23 ALCOHOL BEVERAGE TO A CUSTOMER FOR CONSUMPTION OFF OF THE  
24 LICENSED PREMISES: Section 44-3-402 that operates a sales room or

1 section 44-3-407 that operates a sales room or section 44-3-411,  
2 44-3-413, 44-3-414, 44-3-417, 44-3-418, 44-3-422, 44-3-426, 44-3-428,  
3 44-4-104 (1)(c)(I)(A), or 44-4-104 (1)(c)(III).

4 (II) THIS SECTION AUTHORIZES A LICENSE HOLDER THAT IS ISSUED  
5 A LICENSE UNDER ONE OF THE FOLLOWING SECTIONS TO DELIVER AN  
6 ALCOHOL BEVERAGE TO A CUSTOMER FOR CONSUMPTION OFF OF THE  
7 LICENSED PREMISES: SECTION 44-3-411, 44-3-412, 44-3-413, 44-3-414,  
8 44-3-415, 44-3-416, 44-3-417, 44-3-418, 44-3-419, 44-3-420, 44-3-421,  
9 44-3-422, 44-3-426, OR 44-3-428.

10 (III) THIS SECTION AUTHORIZES A LICENSE HOLDER THAT IS ISSUED  
11 A LICENSE UNDER SECTION 44-3-402 AND THAT OPERATES A SALES ROOM  
12 OR SECTION 44-3-407 AND THAT OPERATES A SALES ROOM TO DELIVER AN  
13 ALCOHOL BEVERAGE TO A CUSTOMER FOR CONSUMPTION OFF OF THE  
14 LICENSED PREMISES. THIS SUBSECTION (6)(a)(III) IS REPEALED, EFFECTIVE  
15 JANUARY 2, 2022.

16 (7) This section is repealed, effective July 1, ~~2021~~ 2026."
