HB21-1305 be amended as follows, and as so amended, be referred to the Committee of the Whole with favorable recommendation and with a recommendation that it be placed on the consent calendar:
Amend reengrossed bill, page 3, line 25, after "(1)(g)," insert "(3)".
Page 3, line 26, strike "(3.5)(b)(II)" and substitute "(3.5)(b)(II); and <b>add</b> (1.5)".
Page 4, line 9, strike "(1)(e)" and substitute (1)(e.5)".
Page 4, after line 13 insert:  "(1.5) The Board May Waive any Education Requirements in Subsection (1)(e) of this section until the department of Human Services establishes the Education Requirements for Licensure Pursuant to Section 27-80-108 (1)(e.5). This subsection (1.5) is Repealed, effective March 1, 2022.  (3) The state board of addiction counselor examiners shall promulgate rules for certification of addiction counselors; except that the state board of human services in the department of human services shall establish by rule education requirements for Licensure and certification in accordance with section 27-80-108 (1)(e) AND (1)(e.5)."
Page 5, after line 19 insert:  "SECTION 5. In Colorado Revised Statutes, 12-245-806, amend (1)(b) introductory portion as follows:  12-245-806. Continuing professional competency - rules -
