Committee on Appropriations.

After consideration on the merits, the Committee recommends the following:

SB21-175 be amended as follows, and as so amended, be referred to the Committee of the Whole with favorable recommendation:

1 Amend printed bill, page 27, strike lines 24 through 26.

2 Renumber succeeding subsection accordingly.

3 Page 28, before line 3 insert:

4 "(5) NOTWITHSTANDING ANY PROVISION OF THIS SECTION TO THE
5 CONTRARY, A CARRIER OR STATE AGENCY THAT IS REQUIRED PURSUANT
6 TO STATE OR FEDERAL LAW TO PURCHASE OR REIMBURSE A PAYER FOR A
7 PRESCRIPTION DRUG FOR WHICH THE BOARD HAS ESTABLISHED AN UPPER
8 PAYMENT LIMIT PURSUANT TO SECTION 10-16-1307 IS NOT SUBJECT TO AN
9 ENFORCEMENT ACTION FOR A VIOLATION OF SUBSECTION (1) OR (2) OF THIS
10 SECTION FOR THAT PARTICULAR PRESCRIPTION DRUG."

11 Page 30, after line 20 insert:

12 "**SECTION 4. Appropriation.** (1) For the 2021-22 state fiscal
13 year, \$680,711 is appropriated to the department of regulatory agencies.
14 This appropriation is from the division of insurance cash fund created in
15 section 10-1-103 (3), C.R.S. To implement this act, the department may
16 use this appropriation as follows:

17 (a) \$275,297 for use by the division of insurance for personal
18 services, which amount is based on an assumption that the division will
19 require an additional 3.0 FTE;

1 (b) \$22,650 for use by the division of insurance for operating
2 expenses; and

3 (c) \$382,824 for the purchase of legal services.

4 (2) For the 2021-22 state fiscal year, \$382,824 is appropriated to
5 the department of law. This appropriation is from reappropriated funds
6 received from the department of regulatory agencies under subsection
7 (1)(c) of this section and is based on an assumption that the department
8 of law will require an additional 2.0 FTE. To implement this act, the
9 department of law may use this appropriation to provide legal services for
10 the department of regulatory agencies."

11 Renumber succeeding sections accordingly.

12 Page 1, line 108, strike "AND".

13 Page 1, line 109, strike "VIOLATIONS." and substitute "VIOLATIONS; AND
14 MAKING AN APPROPRIATION."
