After consideration on the merits, the Committee recommends the following:

SB21-268 be amended as follows, and as so amended, be referred to the Committee on Appropriations with favorable recommendation:

1 Amend reengrossed bill, page 13, strike line 17 and substitute "**add** (3)
2 as follows:".

3 Page 13, line 19, strike "**zones**. (1) Three years after the local" and
4 substitute "**zones - repeal**. (3) (a) NOTWITHSTANDING ANY PROVISION OF
5 THIS SECTION TO THE CONTRARY, A LOCAL SCHOOL BOARD:

6 (I) SHALL NOT REVIEW AN EXISTING INNOVATION SCHOOL,
7 INNOVATION SCHOOL ZONE, OR A PUBLIC SCHOOL INCLUDED IN AN
8 INNOVATION SCHOOL ZONE OR MAKE ANY REVISIONS TO AN EXISTING
9 INNOVATION SCHOOL PLAN OR INNOVATION SCHOOL ZONE PLAN PURSUANT
10 TO THIS SECTION DURING THE 2021-22 SCHOOL YEAR; AND

11 (II) SHALL NOT MAKE REVISIONS TO AN EXISTING INNOVATION
12 SCHOOL OR INNOVATION SCHOOL ZONE PLAN THAT HAVE NOT BEEN
13 APPROVED BEFORE THE EFFECTIVE DATE OF THIS SUBSECTION (3).

14 (b) THIS SUBSECTION (3) IS REPEALED, EFFECTIVE JULY 1, 2022.".

15 Page 13, strike lines 20 through 27.

16 Page 14, strike lines 1 through 13.

17 Page 19, line 21, strike "Each" and substitute "IN PROVIDING NECESSARY
18 SUPPORT SERVICES PURSUANT TO SUBSECTION (1) OF THIS SECTION, each".

19 Page 19, line 27, after "provides" insert "ATTENDANCE SUPPORTS,

- 1 BEHAVIOR INTERVENTION, OR".
- 2 Page 21, lines 8 and 9, strike "in cooperation" and substitute "in
3 ~~cooperation~~ PURSUANT TO AN AGREEMENT".
- 4 Page 21, line 10, strike the second "schools" and substitute "schools."
- 5 Page 21, lines 11 and 12, strike "under contract with the expelling school
6 district." and substitute "~~under contract with the expelling school~~
7 ~~district~~".
- 8 Page 21, strike lines 25 through 27 and substitute "~~nonparochial school,~~
9 ~~or by a pilot school~~ pursuant to an agreement entered into pursuant to
10 ~~subparagraph (f) of paragraph (c) of this subsection (2)~~ SUBSECTION
11 (2)(c)(I) OF THIS SECTION, the expelling school district shall transfer
12 ninety-five".
- 13 Page 28, line 17, strike "~~plan~~" and substitute "~~plan; and~~".
- 14 Page 28, line 21, strike "and".
- 15 Page 28, line 25, strike "GRANT." and substitute "GRANT; AND".
- 16 Page 28, after line 25 insert:
17 "(VIII) THE NEED FOR SERVICES IN RURAL, SUBURBAN, AND URBAN
18 COMMUNITIES."
