After consideration on the merits, the Committee recommends the following:

HB22-1358 be amended as follows, and as so amended, be referred to the Committee of the Whole with favorable recommendation:

- 1 Amend reengrossed bill, page 3, line 11, strike "FIFTH" and substitute
- 2 "EIGHTH".

- 3 Page 6, line 10, strike "AND".

- 4 Page 6, line 13, strike "AMENDED." and substitute "AMENDED; AND
- 5 (IV) ON AND AFTER MAY 31, 2024, ELIGIBLE SCHOOLS THAT SERVE
- 6 STUDENTS IN SIXTH, SEVENTH, OR EIGHTH GRADE."

- 7 Page 7, strike line 14 and substitute "**out by family child care home -**
- 8 **reports. (1) Testing. (a) (I) EXCEPT AS DESCRIBED IN SUBSECTION**
- 9 **(1)(a)(II) OF THIS SECTION, ON OR"**.

- 10 Page 7, after line 23 insert:
- 11 "(II) AN ELIGIBLE SCHOOL THAT SERVES STUDENTS IN SIXTH,
- 12 SEVENTH, OR EIGHTH GRADE SHALL SATISFY THE REQUIREMENT
- 13 DESCRIBED IN SUBSECTION (1)(a)(I) OF THIS SECTION ON OR BEFORE MAY
- 14 31, 2024."

- 15 Page 11, line 10, after "**Reimbursement.**" insert "(a)".

- 16 Page 11, line 12, strike "(a)" and substitute "(I)".

- 17 Page 11, line 16, strike "(b)" and substitute "(II)".

- 18 Page 11, after line 19 insert:
- 19 "(b) NOTWITHSTANDING SUBSECTION (7)(a) OF THIS SECTION, THE
- 20 DEPARTMENT SHALL NOT REIMBURSE AN ELIGIBLE SCHOOL THAT SERVES

1 STUDENTS IN SIXTH, SEVENTH, OR EIGHTH GRADE UNTIL MAY 31, 2024,
2 FOR COSTS INCURRED FOR THE PURPOSE OF COMPLYING WITH THIS
3 SECTION."

4 Page 13, line 25, strike "JANUARY1, 2026," and substitute "DECEMBER 1,
5 2023,".

6 Page 14, strike lines 5 through 10 and substitute "REPORT; AND".

7 Reletter succeeding paragraph accordingly.

8 Page 16, line 13, strike "\$18,000,000" and substitute "\$21,000,000".

9 Page 16, line 18, strike "\$18,000,000" and substitute "\$21,000,000".
