2 "(f) ANY UNEXPENDED AND UNENCUMBERED MONEY IN THE
3 ACCOUNT AT THE END OF ANY FISCAL YEAR REMAINS IN THE ACCOUNT AND
4 SHALL NOT BE CREDITED OR TRANSFERRED TO THE GENERAL FUND.

5 **SECTION 3.** In Session Laws of Colorado 2021, section 4 of
6 chapter 400, (HB21-1290), **amend** (1) as follows:

7 Section 4. **Appropriation.** (1) For the 2020-21 state fiscal year,
8 \$8,000,000 is appropriated to the department of labor and employment for
9 use by the division of employment and training, just transition office. This
10 appropriation is from the just transition cash fund created in section
11 8-83-504 (1), C.R.S., and is based on an assumption that the department
12 will require an additional 1.0 FTE. To implement this act, the department
13 may use this appropriation for the purposes specified in section 8-83-504
14 (4), C.R.S. Any money appropriated in this section not expended prior to
15 July 1, 2021, is further appropriated to the just transition office for the
16 2021-22, ~~and~~ 2022-23, AND 2023-24 state fiscal years for the same
17 purpose.

18 **SECTION 4.** In Session Laws of Colorado 2022, section 5 of
19 chapter 11, (HB22-1193), **amend** (3) and (4) as follows:

20 Section 5. **Appropriation.** (3) For the 2021-22 state fiscal year,
21 \$1,295,000 is appropriated to the department of labor and employment for
22 use by the division of employment and training. This appropriation is
23 from the just transition cash fund created in section 8-83-504 (1), C.R.S.
24 To implement this act, the division may use this appropriation for the
25 purposes specified in section 8-83-504, C.R.S. ANY MONEY
26 APPROPRIATED IN THIS SUBSECTION (3) NOT EXPENDED BEFORE JULY 1,
27 2022, IS FURTHER APPROPRIATED TO THE DEPARTMENT FOR THE 2022-23
28 AND 2023-24 STATE FISCAL YEARS FOR THE SAME PURPOSE.

29 (4) For the 2022-23 state fiscal year, \$555,000 is appropriated to
30 the department of labor and employment for use by the division of
31 employment and training. This appropriation is from the just transition
32 cash fund created in section 8-83-504 (1), C.R.S. To implement this act,
33 the division may use this appropriation for the purposes specified in
34 section 8-83-504, C.R.S. ANY MONEY APPROPRIATED IN THIS SUBSECTION
35 (4) NOT EXPENDED BEFORE JULY 1, 2023, IS FURTHER APPROPRIATED TO
36 THE DEPARTMENT FOR THE 2023-24 STATE FISCAL YEAR FOR THE SAME
37 PURPOSE."
