## MEMORIALIZING FORMER REPRESENTATIVE JOE NUÑEZ.

WHEREAS, Our respected former colleague, Joe Nuñez, a past member of the Colorado General Assembly, departed this life on November 16, 2020; and

WHEREAS, Representative Nuñez was born April 5, 1937, in Greeley, Colorado, to Manuela Nuñez and Concepción Lopez; and

WHEREAS, Representative Nuñez was a Vietnam veteran who served our nation in the United States Air Force and retired at the rank of Lieutenant Colonel from his last duty assignment at F. E. Warren Air Force Base in Cheyenne, Wyoming; and

WHEREAS, Representative Nuñez received the Bronze Star, the Meritorious Service Medal with one Oak Leaf Cluster, the Republic of Vietnam Campaign Medal, and the Republic of Vietnam Gallantry Cross with palm; and

WHEREAS, In 1998, Representative Nuñez ran for and was elected to the Colorado House of Representatives for House District 64 and in 2000 he ran again and was reelected; and

WHEREAS, During his three years serving as a member of the House of Representatives, Representative Nuñez served on the Transportation and Energy, Appropriations, and Education Committees and as Vice-chair for the State, Veterans, and Military Affairs Committee; and

WHEREAS, Representative Nuñez also served as the representative for Secretary of the United States Department of Labor for the Rocky Mountain Region and as the Regional Director for the United States Department of Health and Human Services; and


