Committee on Appropriations.

After consideration on the merits, the Committee recommends the following:

SB22-178 be amended as follows, and as so amended, be referred to the Committee of the Whole with favorable recommendation and with a recommendation that it be placed on the consent calendar:

1 Amend the Senate Finance Committee Report, dated April 13, 2022, page
2 1, strike lines 7 and 8 and substitute "CULTIVATION FACILITY SHALL
3 NOTIFY THE LOCAL LICENSING AUTHORITY IN THE LOCAL JURISDICTION
4 WHERE THE TRANSFEROR AND TRANSFEREE OPERATE AND PAY ANY
5 APPLICABLE EXCISE TAX ON THE TRANSFERRED RETAIL MARIJUANA."

6 Page 1 of the report, strike lines 9 through 11 and substitute:
7 "(e) PURSUANT TO THE REQUIREMENTS OF THIS SUBSECTION (9.5),
8 A MEDICAL MARIJUANA CULTIVATION FACILITY MAY MAKE A VIRTUAL
9 TRANSFER OF MARIJUANA THAT IS REFLECTED IN THE SEED-TO-SALE
10 TRACKING SYSTEM EVEN IF THE MARIJUANA IS NOT PHYSICALLY MOVED OR
11 TRANSFERRED."."

12 Page 1 of the report, strike lines 18 and 19 and substitute "CULTIVATION
13 FACILITY SHALL NOTIFY THE LOCAL LICENSING AUTHORITY IN THE LOCAL
14 JURISDICTION WHERE THE TRANSFEROR AND TRANSFEREE OPERATE AND
15 PAY ANY APPLICABLE EXCISE TAX ON THE TRANSFERRED RETAIL
16 MARIJUANA."

17 Page 1 of the report, strike lines 20 through 22 and substitute:
18 "(e) PURSUANT TO THE REQUIREMENTS OF THIS SUBSECTION (13.5),
19 A RETAIL MARIJUANA CULTIVATION FACILITY MAY RECEIVE A VIRTUAL
20 TRANSFER OF MARIJUANA THAT IS REFLECTED IN THE SEED-TO-SALE
21 TRACKING SYSTEM EVEN IF THE MARIJUANA IS NOT PHYSICALLY MOVED OR
22 TRANSFERRED."."

23 Page 1 of the report, strike line 23.

1 Amend printed bill, page 2, line 5, strike "AFTER" and insert "STARTING
2 JANUARY 1, 2023, AFTER".

3 Page 3 of the printed bill, line 27, strike "AFTER" and insert "STARTING
4 JANUARY 1, 2023, AFTER".

5 Page 5 of the printed bill, after line 16 insert:

6 **"SECTION 3 Appropriation.** For the 2022-23 state fiscal year,
7 \$228,510 is appropriated to the department of revenue for use by the
8 marijuana enforcement division. This appropriation is from the marijuana
9 cash fund created in section 44-10-801 (1)(a), C.R.S., and is based on an
10 assumption that the division will require an additional 2.9 FTE. To
11 implement this act, the division may use this appropriation for marijuana
12 enforcement.".

13 Renumber succeeding sections accordingly.

14 Page 1 of the printed bill line 103, strike "RETAIL." and substitute
15 "RETAIL, AND, IN CONNECTION THEREWITH, MAKING AN
16 APPROPRIATION.".
