CONCERNING MANDATORY ANNUAL TRAINING BY SAFE2TELL FOR SCHOOL RESOURCE OFFICER TRAINING.

Be it enacted by the General Assembly of the State of Colorado:

SECTION 1. In Colorado Revised Statutes, 24-31-606, **add** (4) as follows:

24-31-606. Safe2tell program - creation - duties. (4) BEGINNING ON OR BEFORE AUGUST 1, 2024, THE DEPARTMENT SHALL ANNUALLY CONVENE A TRAINING MEETING FOR SCHOOL RESOURCE OFFICERS, AS DESCRIBED IN SECTION 22-32-146, AND SCHOOL OFFICIALS TO DISCUSS BEST PRACTICES IN RESPONDING TO SAFE2TELL REPORTS, INCLUDING DEFINING ROLES, COMMUNICATION ABOUT A REPORT, OUTCOME REPORTING, AND

TRAINING RESOURCES TO IMPROVE SCHOOL RESOURCE OFFICERS' SUPPORT OF STUDENTS AND SCHOOL STAFF. SAFE2TELL MAY CONDUCT A SURVEY TO COLLECT DATA AND DISCUSSIONS REGARDING SAFE2TELL OPERATIONS.


SECTION 2. Safety clause. The general assembly hereby finds, determines, and declares that this act is necessary for the immediate preservation of the public peace, health, or safety.
