Committee on Appropriations.

After consideration on the merits, the Committee recommends the following:

HB23-1008 be amended as follows, and as so amended, be referred to the Committee of the Whole with favorable recommendation:

- 1 Amend reengrossed bill, page 3, after line 16 insert:
2 "SECTION 2. In Colorado Revised Statutes, 25-20.5-104, add
3 (2.5) as follows:
4 **25-20.5-104. Functions of division.** (2.5) (a) FOR STATE FISCAL
5 YEAR 2023-24, THE GENERAL ASSEMBLY SHALL APPROPRIATE TWO
6 HUNDRED AND FIFTY THOUSAND DOLLARS TO THE DIVISION FOR THE
7 DIVISION TO PARTNER WITH A STATEWIDE NONPROFIT ORGANIZATION TO
8 PROVIDE HEALTHY EATING PROGRAM INCENTIVES AMONG COLORADO'S
9 LOW-INCOME POPULATIONS. THESE PROGRAM INCENTIVES MUST ATTEMPT
10 TO IMPROVE ACCESS TO FRESH COLORADO-GROWN FRUITS AND
11 VEGETABLES AMONG COLORADO'S LOW-INCOME POPULATIONS.
12 (b) THE STATEWIDE NONPROFIT ORGANIZATION SELECTED BY THE
13 DIVISION FOR THE PARTNERSHIP DESCRIBED IN THIS SUBSECTION (2.5)
14 SHALL HAVE EXPERIENCE IN SUPPORTING HEALTHY EATING INCENTIVES
15 PROGRAMS, SUCH AS PROGRAMS AT LOCAL FARMERS MARKETS, AND
16 EXPERIENCE WITH COORDINATING HEALTHY EATING PROGRAMS AND
17 FUNDING BETWEEN LOCAL, STATE, AND FEDERAL PROGRAMS.
18 (c) IN PROVIDING THE PROGRAM INCENTIVES DESCRIBED IN THIS
19 SUBSECTION (2.5), BOTH THE DIVISION AND THE NONPROFIT SHALL
20 MINIMIZE THEIR ADMINISTRATIVE EXPENSES. THE DIVISION SHALL NOT USE
21 MORE THAN TEN THOUSAND DOLLARS AND THE NONPROFIT SHALL NOT USE
22 MORE THAN FIVE PERCENT OF THE AMOUNT TRANSFERRED PURSUANT TO
23 SUBSECTION (2.5)(a) OF THIS SECTION FOR THEIR ADMINISTRATIVE
24 EXPENSES.
25 (d) THE DIVISION SHALL USE THE FUNDING PROVIDED IN
26 SUBSECTION (2.5)(a) OF THIS SECTION TO SUPPLEMENT, NOT SUPPLANT,
27 OTHER GENERAL FUND APPROPRIATIONS TO THE DIVISION.
28 (e) ALL BUT SEVENTY-SEVEN THOUSAND SEVEN HUNDRED AND

- 1 FIFTY TWO DOLLARS OF THE AMOUNT TRANSFERRED PURSUANT TO
2 SUBSECTION (2.5)(a) OF THIS SECTION MUST BE EXPEND FOR HEALTHY
3 EATING PROGRAM INCENTIVES AMONG COLORADO'S LOW-INCOME
4 POPULATIONS.
- 5 (f) THIS SUBSECTION (2.5) IS REPEALED, EFFECTIVE SEPTEMBER 1,
6 2025."
- 7 Renumber succeeding sections accordingly.
- 8 Page 13, line 7, strike "\$337,878" and substitute "\$360,413".
- 9 Page 13, line 10, strike "\$88,286" and substitute "\$98,185".
- 10 Page 13, after line 12 insert:
11 "(b) \$45,579 for use by the commissioner's office for operating
12 expenses;".
- 13 Page 13, line 13, strike "(b)" and substitute "(c)".
- 14 Page 13, line 15, strike "(c) \$205,181" and substitute "(d) \$172,238".
- 15 Page 13, line 17, strike "1.8 FTE" and substitute "2.0 FTE".
- 16 Page 13, line 20, strike "(1)(b)" and substitute "(1)(c)".
- 17 Page 13, strike lines 23 through 27 and substitute:
18 "(3) For the 2023-24 state fiscal year, \$250,000 is appropriated to
19 the department of public health and environment for use by the prevention
20 services division. This appropriation is from the general fund. To
21 implement this act, the division may use this appropriation for chronic
22 disease and cancer prevention grants for the purposes specified in
23 25-20.5-104 (2.5)(a), C.R.S."
- 24 Page 14, strike lines 1 through 4.
- 25 Page 1, line 106, after "PROGRAM," insert "PROVIDING FUNDING FOR
26 HEALTHY EATING PROGRAM INCENTIVES,".
