After consideration on the merits, the Committee recommends the following:

SB23-012 be amended as follows, and as so amended, be referred to the Committee on Appropriations with favorable recommendation:

1 Amend reengrossed bill, page 3, strike lines 4 through 13 and substitute:

2 "(d) (I) PURSUANT TO SECTION 42-3-120, upon notice from the
3 Colorado state patrol, ~~the department shall, pursuant to section 42-3-120, cancel~~
4 ~~the registration of a motor carrier who~~ FOR A CARRIER THAT fails to pay in full
5 a civil penalty imposed pursuant to this subsection (2) within thirty days after
6 notification of the penalty OR FAILS TO COOPERATE WITH THE COMPLETION OF
7 A COMPLIANCE REVIEW WITHIN THIRTY DAYS AFTER NOTIFICATION OF THE
8 FAILURE TO COOPERATE, THE DEPARTMENT SHALL:
9 (A) CANCEL THE MOTOR CARRIER'S REGISTRATION; AND
10 (B) ENTER BOTH THE MOTOR CARRIER AND ITS VEHICLES AS
11 OUT-OF-SERVICE IN THE FEDERAL MOTOR CARRIER SAFETY ADMINISTRATION
12 SYSTEM OF RECORD."

13 Page 3, strike line 23 and substitute "carrier;

14 (II) ENTER BOTH THE MOTOR CARRIER AND ITS VEHICLES AS".

15 Page 3, line 26, strike "(II)" and substitute "(III)".

16 Page 4, strike lines 17 through 25 and substitute:

17 "**SECTION 4. Act subject to petition - effective date.** Section
18 42-4-235 (2)(d)(I)(B), Colorado Revised Statutes, as enacted in section
19 1 of this act, and section 42-3-120 (3)(a)(II), Colorado Revised Statutes,
20 as enacted in section 2 of this act take effect April 31, 2024, and the
21 remainder of this act takes effect at 12:01 a.m. on the day following the
22 expiration of the ninety-day period after final adjournment of the general
23 assembly; except that, if a referendum petition is filed pursuant to section

1 1 (3) of article V of the state constitution against this act or an item,
2 section, or part of this act within such period, then the act, item, section,
3 or part will not take effect unless approved by the people at the general
4 election to be held in November 2024 and, in such case, will take effect
5 on the date of the official declaration of the vote thereon by the
6 governor.".
