Committee on Education.

After consideration on the merits, the Committee recommends the following:

SB23-065 be amended as follows, and as so amended, be referred to the Committee on Appropriations with favorable recommendation:

1 Amend printed bill, page 2, strike line 4 and substitute "(1)(i)(IV), (5)(e),
2 and (5)(f) as follows:".

3 Page 3, line 13, strike "TEN" and substitute "FIVE".

4 Page 3, after line 25 insert:

5 (f) (I) FOR THE 2023-24 BUDGET YEAR, THE DEPARTMENT OF
6 EDUCATION SHALL PROVIDE AN ADDITIONAL AMOUNT OF MONEY EQUAL
7 TO THE TOTAL AMOUNT OF PER PUPIL MONEY AWARDED PURSUANT TO
8 SUBSECTION (5)(b)(I) OF THIS SECTION TO ANY PARTICIPATING DISTRICT,
9 PARTICIPATING CHARTER SCHOOL, THE INSTITUTE ON BEHALF OF EACH
10 PARTICIPATING INSTITUTE CHARTER SCHOOL, AND PARTICIPATING BOARD
11 OF COOPERATIVE SERVICES THAT DEMONSTRATES, AS OF THE 2023-24
12 SCHOOL YEAR, THAT ALL STUDENTS ARE REQUIRED TO ENROLL IN AND
13 SUCCESSFULLY COMPLETE AT LEAST ONE QUALIFIED
14 INDUSTRY-CREDENTIAL PROGRAM; ONE QUALIFIED WORKPLACE TRAINING
15 PROGRAM; OR ONE QUALIFIED ADVANCED PLACEMENT COURSE PRIOR TO
16 GRADUATION. A SCHOOL DISTRICT MAY ALSO RECEIVE MONEY FOR AN
17 INDIVIDUAL SCHOOL WITHIN THE SCHOOL DISTRICT THAT CAN
18 DEMONSTRATE SUCH REQUIREMENTS.

19 (II) FOR THE 2023-24 BUDGET YEAR, THE GENERAL ASSEMBLY
20 SHALL APPROPRIATE FIVE MILLION DOLLARS TO THE DEPARTMENT OF
21 EDUCATION FOR THE PURPOSES OF THIS SUBSECTION (5)(f). ANY MONEY
22 RECEIVED PURSUANT TO THIS SUBSECTION (5)(f) MUST BE USED TO
23 PROMOTE THE AVAILABILITY OF QUALIFIED INDUSTRY-CREDENTIAL
24 PROGRAMS, QUALIFIED WORKPLACE TRAINING PROGRAMS, AND QUALIFIED
25 ADVANCED PLACEMENT COURSES. THE DEPARTMENT OF EDUCATION MAY

1 REALLOCATE ANY REMAINING MONEY RECEIVED PURSUANT TO THIS
2 SUBSECTION (5)(f) FOR THE PURPOSES DESCRIBED IN SUBSECTION (5)(b)(I)
3 OF THIS SECTION.
4 (III) THIS SUBSECTION (5)(f) IS REPEALED, EFFECTIVE JULY 1,
5 2024."
