After consideration on the merits, the Committee recommends the following:

<u>HB24-1362</u> be amended as follows, and as so amended, be referred to the Committee on <u>Finance</u> with favorable recommendation:

1 Amend printed bill, page 3, after line 5 insert:

2 "(c) A BOARD OF COUNTY COMMISSIONERS OR GOVERNING BODY 3 OF A MUNICIPALITY THAT HAS NOT PROHIBITED THE INSTALLATION OF 4 GRAYWATER TREATMENT WORKS PURSUANT TO SUBSECTION (2)(a)(I) OF 5 THIS SECTION, PRIOR TO INSTALLATION OF ANY GRAYWATER TREATMENT 6 WORKS, CONTINUES TO BE RESPONSIBLE FOR ADOPTING BUILDING CODES 7 THAT PREVENT GRAYWATER FROM ENTERING A POTABLE WATER SYSTEM 8 AND FOR REPORTING TO THE LOCAL WATER UTILITY THE PLANNED 9 INSTALLATION OF GRAYWATER SYSTEMS THAT REQUIRE BACKFLOW 10 PREVENTION CROSS-CONNECTION CONTROL DEVICES UNDER THE 11 COMMISSION'S RULES FOR THE PURPOSE OF SURVEYING AND TRACKING 12 SUCH DEVICES. FOR EACH LOCATION WITHIN A LOCAL GOVERNMENT'S 13 JURISDICTION AT WHICH GRAYWATER TREATMENT WORKS HAVE BEEN 14 INSTALLED, THE BUILDING DEPARTMENT OF THE LOCAL GOVERNMENT 15 SHALL PROVIDE THE ADDRESS OF THE LOCATION TO EACH WATER UTILITY 16 SERVING THAT LOCATION.".

17 Page 3, after line 15 insert:

"(4) UNLESS A BOARD OF COUNTY COMMISSIONERS OR GOVERNING
BODY OF A MUNICIPALITY ADOPTS A RESOLUTION OR AN ORDINANCE TO
THE CONTRARY, A PERSON MAY INSTALL INDOOR GRAYWATER TREATMENT
WORKS PURSUANT TO SUBSECTION (1) OF THIS SECTION ONLY IN NEW
CONSTRUCTION PROJECTS.".

23 Amend printed bill, page 7, strike lines 22 through 27.

- 1 Strike pages 8, 9, and 10.
- 2 Renumber succeeding section accordingly.
- 3 Strike page 11 and substitute:

"SECTION 6. Act subject to petition - effective date. This act 4 takes effect January 1, 2026; except that, if a referendum petition is filed 5 pursuant to section 1 (3) of article V of the state constitution against this 6 act or an item, section, or part of this act within the ninety-day period 7 after final adjournment of the general assembly, then the act, item, 8 9 section, or part will not take effect unless approved by the people at the general election to be held in November 2024 and, in such case, will take 10 effect January 1, 2026, or on the date of the official declaration of the 11 vote thereon by the governor, whichever is later.". 12
