After consideration on the merits, the Committee recommends the following:

SB24-205 be amended as follows, and as so amended, be referred to the Committee of the Whole with favorable recommendation:

- 1 Amend reengrossed bill, page 7, line 15 after "COMMUNICATES" insert  
2 "WITH CONSUMERS".
  
- 3 Page 13, lines 6 and 7, strike "OTHER CONFIDENTIAL OR PROPRIETARY  
4 INFORMATION," and substitute "INFORMATION PROTECTED FROM  
5 DISCLOSURE BY STATE OR FEDERAL LAW,".
  
- 6 Page 13, line 11, before "IN" insert "NO LATER THAN NINETY DAYS AFTER  
7 THE REQUEST AND".
  
- 8 Page 22, lines 21 and 22, strike "OTHER CONFIDENTIAL OR PROPRIETARY  
9 INFORMATION." and substitute "INFORMATION PROTECTED FROM  
10 DISCLOSURE BY STATE OR FEDERAL LAW. TO THE EXTENT THAT A  
11 DEPLOYER WITHHOLDS INFORMATION PURSUANT TO THIS SUBSECTION (8),  
12 THE DEPLOYER SHALL NOTIFY THE CONSUMER AND PROVIDE A BASIS FOR  
13 THE WITHHOLDING.".
  
- 14 Page 22, line 25, before "IN" insert "NO LATER THAN NINETY DAYS AFTER  
15 THE REQUEST AND".
  
- 16 Page 26, line 16, strike "TECHNOLOGY;" and substitute "TECHNOLOGY IF  
17 THE STANDARDS ARE SUBSTANTIALLY EQUIVALENT OR MORE STRINGENT  
18 THAN THE REQUIREMENTS OF THIS PART 16;".
  
- 19 Page 27, strike lines 23 through 27 and substitute:  
  
20 "(7) AN INSURER, AS DEFINED IN SECTION 10-1-102 (13), A  
21 FRATERNAL BENEFIT SOCIETY, AS DESCRIBED IN SECTION 10-14-102, OR A

1 DEVELOPER OF AN ARTIFICIAL INTELLIGENCE SYSTEM USED BY AN INSURER  
2 IS IN FULL COMPLIANCE WITH THIS PART 16 IF THE INSURER, THE  
3 FRATERNAL BENEFIT SOCIETY, OR THE DEVELOPER IS SUBJECT TO THE  
4 REQUIREMENTS OF SECTION 10-3-1104.9 AND ANY RULES ADOPTED BY THE  
5 COMMISSIONER OF INSURANCE PURSUANT TO SECTION 10-3-1104.9."

6 Page 28, strike lines 1 through 4.

7 Page 30, line 2, after "DISCOVERS" insert "AND CURES".
