SB25-017 be amended as follows, and as so amended, be referred to the Committee on Appropriations with favorable recommendation:

- 1 Amend printed bill, page 5, lines 20 and 21, strike "EARLY CHILDHOOD
- 2 LEARNING AND KNOWLEDGE CENTER ADMINISTERED BY THE".

- 3 Page 7, line 9, strike "SHALL" and substitute "MAY".

- 4 Page 10, line 15, strike "SHALL" and substitute "MAY".

- 5 Page 11, line 16, strike "SHALL" and substitute "MAY".

- 6 Page 12, line 9, strike "SHALL" and substitute "MAY".

- 7 Page 12, line 12, strike "SHALL" and substitute "MAY".

- 8 Page 12, line 25, strike "IMPROVE ACCESS TO THE PROGRAM," and

- 12 "(4) THE DEPARTMENT IS NOT OBLIGATED TO IMPLEMENT THIS
- 13 PART 10 UNTIL THE DEPARTMENT HAS SUFFICIENT APPROPRIATIONS TO
- 14 COVER THE COSTS OF THE PROGRAM.".

- 2 Page 14, line 3, strike "DEPARTMENT."
- 3 Page 14, line 9, strike "CREATE, IMPLEMENT," and substitute "IMPLEMENT,
4 OPERATE,".
- 5 Page 16, lines 20 and 21, strike "IMPROVE ACCESS TO THE PROGRAM," and
6 substitute "IMPLEMENT THE PROGRAM AND THE REQUIREMENTS OF THIS
7 PART 11,".
- 8 Page 17, after line 3 insert:
9 "(4) THE DEPARTMENT IS NOT OBLIGATED TO IMPLEMENT THIS
10 PART 11 UNTIL THE DEPARTMENT HAS SUFFICIENT APPROPRIATIONS TO
11 COVER THE COSTS OF THE PROGRAM."
