Does JBC staff believe the request satisfies the interim supplemental criteria of Section 24-75-111, C.R.S.? [The Controller may authorize an overexpenditure of the existing appropriation if it: (1) Is approved in whole or in part by the JBC; (2) Is necessary due to unforeseen circumstances arising while the General Assembly is not in session; (3) Is approved by the Office of State Planning and Budgeting (except for State, Law, Treasury, Judicial, and Legislative Departments); (4) Is approved by the Capital Development Committee, if a capital request; (5) Is consistent with all statutory provisions applicable to the program, function or purpose for which the overexpenditure is made; and (6) Does not exceed the unencumbered balance of the fund from which the overexpenditure is to be made.]

**Does JBC staff believe the request meets the Joint Budget Committee's supplemental criteria?** [An emergency or act of God; a technical error in calculating the original appropriation; data that was not available when the original appropriation was made; or an unforseen contingency.]

\*JBC staff and the Department agree this request meets the JBC's supplemental criteria and is based on data not available when the original appropriation was made. It is not clear to staff that the request addresses "unforeseen circumstances arising while the General Assembly is not in session" as staff assumes the need for an extension was obvious before the General Assembly adjourned. However, staff also notes that the circumstances are unusual due to changes in the law regarding appropriation of higher education cash-funded projects. If the project had been authorized after January 1, 2010, no supplemental would have been required.

**Department Request:** The Department requests that an existing appropriation, last adjusted in FY 2009-10, for the Colorado State University Research Innovation Center be extended through June 30, 2016. The total project, including appropriations starting in FY 2007-08, is for \$62,700,000, including \$52,000,000 cash funds exempt and \$10,700,000 federal funds.

**Staff Recommendation:** Staff recommends that the Committee approve the request, which was approved by the Capital Development Committee at its May 20, 2013 meeting.

The rules governing interim supplementals in Section 24-75-111 (5), C.R.S., require the Committee to introduce all interim supplementals that it approves.

**Staff Analysis:** The interim supplemental request extends spending authority in order to complete two additions to the Regional Biocontainment Laboratory, an infectious disease and bioterrorism research facility. The project was initially approved in FY 2007-08, but federal grant funding was not received until 2010, and reviews associated with the grant funding delayed the start of the construction until 2011.

#### **GENERAL INFORMATION**

2008-194

1. Which supplemental criterion does the request meet?

Technical

Capital construction projects listed in an annual appropriations bill are permitted three years to expend appropriations. Spending authority for this project will expire June 30, 2013. If the appropriation is not expended, the university will not be able to support the highly specialized research conducted in the biosafety level 2 research laboratory, which will negatively impact its ability to compete for future grant funding.

2. Which projects will be restricted to fund the supplemental request?

No emergency restriction is required because the request is for an extension of time only.

#### REASON FOR SUPPLEMENTAL REQUEST

The supplemental request extends spending authority in order to complete construction on the project. The university received grant funding for the project through the National Institutes of Health in January 2010. Project design commenced immediately; however, reviews associated with the grant funding delayed the start of construction until 2011.

#### SUMMARY OF PROJECT

The project completes construction of two additions totaling 72,000 GSF to the Regional Biocontainment Laboratory, an infectious disease and bioterrorism research facility. This request will bury overhead electric transmission lines, purchase a Magnetic Resonance Imaging (MRI) machine, and build an MRI suite. The project was previously approved in FY 2007-08, but the university amended the request during the 2009 legislative session in order to take advantage of potential National Institutes of Health grants.
