#### REQUEST/RECOMMENDATION DESCRIPTIONS

**NP Property Fund Supplemental:** The request includes an increase of \$7,984 total funds, including an increase of \$639 General Fund, for FY 2016-17 for an adjustment to the Department's share of liability and property insurance carried the Department of Personnel. This request item will be addressed in a separate staff supplemental recommendations presentation for the Department of Personnel on January 12, 2017. Staff will incorporate the Committee's action into the supplemental bill. Note, the dollar amounts in the previous table represent the requested appropriation change.

**NP Annual Fleet Supplemental:** The request includes a decrease of \$29,621 total funds for FY 2016-17 for an adjustment to the Department's share of expenses related to leasing fleet vehicles through the Department of Personnel. This request item will be addressed in a separate staff supplemental recommendations presentation for the Department of Personnel on January 12, 2017. Staff will incorporate the Committee's action into the supplemental bill. Note, the dollar amounts in the previous table represent the requested appropriation change.
