DEC 1331 LOCAL ELECTION REIMBURSEMENT: The Department requested, and the Committee approved, an increase of \$200,000 cash funds spending authority for the Department to fulfill statutory obligations of providing reimbursement to counties for administering statewide ballot questions.

DEPARTMENT REQUEST: The Department requested an increase of \$200,000 cash funds from the Department of State Cash Fund to fulfill its statutory obligation to provide election reimbursement to counties based on the active registered voters in each county on election day.

SUMMARY: Statute requires the Committee to introduce all interim supplemental budget requests that it approves pursuant to Section 24-75-111 (5), C.R.S.

COMMITTEE ACTION: Staff recommended, and the Committee approved, additional cash fund spending authority in FY 2016-17 for the Local Election Reimbursement line item based on the statutory county reimbursement formula contained in Section 1-5-505.5, C.R.S. and calculated using the actual number of registered voters on election day.
