REQUEST/RECOMMENDATION DESCRIPTIONS

**COLORADO SCHOOL OF MINES SUBSURFACE FRONTIERS BUILDING:** The Colorado Commission on Higher Education (CCHE) requests the elimination of the appropriation for the Colorado School of Mines (CSM) Subsurface Frontiers Building due to the project being directly funded by the federal Infrastructure Investment and Jobs Act signed in November 2021. The building will be constructed in partnership with the United States Geological Survey (USGS) on the Mines campus and will house both organizations' mineral exploration and subsurface mineral economics programs.

REQUEST/RECOMMENDATION DESCRIPTIONS

**COLORADO STATE UNIVERSITY SHEPARDSON BUILDING RENOVATION & ADDITION:** CCHE requests a reduction in a cash appropriation authorized in FY 2020-21 for Colorado State University's Shepardson Building Renovation and Addition Project. The original request anticipated the project would require \$33.8 million from the Capital Construction Fund (CCF) with a \$9.0 million cash match from CSU. The project was appropriated \$4.5 million CCF in FY 2018-19 and \$13.5 million CCF and \$9.0 million cash in FY 2019-20. The final phase did not receive funding in FY 2020-21 due to the COVID-19 pandemic, but the FY 2020-21 Long Bill included \$3.1 million cash funds spending authority as a bridge to keep the project going until additional funding was secured. Senate Bill 20-219 provided \$17.0 million from certificates of participation to complete the project; CSU therefore did not need the \$3.1 million appropriation and seeks a rescission of said spending authority.

REQUEST/RECOMMENDATION DESCRIPTIONS

**INTERIM SUPPLEMENTAL – DEPARTMENT OF HUMAN SERVICES: EMERGENCY SUICIDE MITIGATION, COLORADO MENTAL HEALTH INSTITUTE AT PUEBLO:** The Department of Human Services (DHS) requested, and the Capital Development Committee and JBC approved, an increase of \$4,113,216 Capital Construction Fund (General Fund) to address suicide risk mitigation items at the Colorado Mental Health Institute at Pueblo (CMHIP) as an outcome of a July 2021 Colorado Department of Public Health and Environment survey executed in response to a serious life-safety incident at the facility.

**Does JBC staff believe the request meets the Joint Budget Committee's supplemental criteria? YES** [An emergency or act of God; a technical error in calculating the original appropriation; data that was not available when the original appropriation was made; or an unforeseen contingency.]

**Explanation:** JBC staff and the Department agree that this request is the result of data that was not available when the original appropriation was made.

DEPARTMENT REQUEST: CCHE requests the elimination of the appropriation for the Colorado School of Mines Subsurface Frontiers Building due to funding for the project being provided by the federal Infrastructure Investment and Jobs Act signed in November 2021.

CAPITAL DEVELOPMENT COMMITTEE ACTION: The Capital Development Committee approved the request on January 13, 2022 and forwarded it to the JBC.

STAFF RECOMMENDATION: Staff recommends that the Committee approve the request. This will require a supplemental adjustment to reduce the FY 2019-20 Capital Construction Fund and cash funds appropriation by \$1.9 million and \$120.0 million, respectively. The intent is to relieve Mines of the requirement to fund the cash match and true-up CCF committed to this project.

STAFF ANALYSIS: The Colorado School of Mines Subsurface Frontiers Building received an appropriation of \$121.9 million in FY 2019-20, consisting of \$1.9 million CCF and \$120.0 million cash funds. After a couple years of uncertainty around how the partnership with the USGS would pan out, the project received \$167.0 million directly from federal funding in the Infrastructure Investment and Jobs Act signed in November 2021. The building will be constructed in partnership with the USGS on the Mines campus and will house both organizations' mineral exploration and subsurface mineral economics programs.

**Does JBC staff believe the request meets the Joint Budget Committee's supplemental criteria?** YES [An emergency or act of God; a technical error in calculating the original appropriation; data that was not available when the original appropriation was made; or an unforeseen contingency.]

**Explanation:** JBC staff and the Department agree that this request is the result of new data that was no available when the original appropriation was made.

DEPARTMENT REQUEST: CCHE requests a reduction in the \$3.1 million cash appropriation authorized in FY 2020-21 for Colorado State University's Shepardson Building Renovation and Addition Project.

CAPITAL DEVELOPMENT COMMITTEE ACTION: The Capital Development Committee approved the request on January 13, 2022 and forwarded it to the JBC.

STAFF RECOMMENDATION: **Staff recommends that the Committee approve the request.** This will require a supplemental adjustment to reduce the FY 2020-21 cash funds appropriation by \$3.1 million. The intent is to relieve CSU of the requirement to fund this portion of the match it had committed for the project.

STAFF ANALYSIS: The original request anticipated the project would require \$33.8 million from the Capital Construction Fund with a \$9.0 million cash match from CSU. The project was appropriated \$4.5 million CCF in FY 2018-19 and \$13.5 million CCF and \$9.0 million cash in FY 2019-20. The final phase did not receive funding in FY 2020-21 due to the COVID-19 pandemic, but the FY 2020-21 Long Bill included \$3.1 million cash funds spending authority as a bridge to keep the project going until additional funding was secured. Senate Bill 20-219 provided \$17.0 million in funding from certificates of participation to complete the project; CSU therefore did not need the \$3.1 million appropriation and seeks a rescission of said spending authority. If this request is approved, CSU's cash contribution to the project would remain at \$9.0 million as planned in the original project request.

DEPARTMENT REQUEST/CDC ACTION: The Department of Human Services requested, and the CDC approved, an increase of \$4,113,216 Capital Construction Fund (General Fund) to address suicide risk mitigation at CMHIP as an outcome of a July 2021 Colorado Department of Public Health and Environment survey executed in response to a serious life-safety incident at the facility.

ADDITIONAL STAFF RECOMMENDATION: Staff recommends the Committee pursue legislation for a General Fund transfer to the Capital Construction Fund of \$4,113,216 to support this previously approved request.

SUMMARY: Due to the potential revocation of licensure and accreditation, loss of federal funding, and inability to serve patients if the issues were not mitigated immediately, the CDC and JBC approved the request for emergency suicide mitigation funding. The CDC and JBC also approved a name and project scope change for the FY 2021-22 Capital Construction appropriation for *HVAC Replacement in Four Buildings, Colorado Mental Health Institute at Pueblo (Capital Renewal)* to include Emergency Suicide Mitigation.

Staff included the following in the interim supplemental staff write-up:

"In order to be compliant with the interim supplemental criteria in Section 24-75-111, C.R.S., the request must be for an expenditure "*in excess of the amount authorized by an item of appropriation for such fiscal year*...". The request as originally submitted did not specify an existing appropriation that would be overexpended through this request. However, OSPB clarified to JBC staff that the request for a change in name and scope of *HVAC Replacement in Four Buildings, Colorado Mental Health Institute at Pueblo (Capital Renewal)* to *HVAC Replacement in Four Buildings and Emergency Suicide Mitigation, Colorado Mental Health Institute at Pueblo (Capital Renewal)*, if approved by both the CDC and JBC, is the existing appropriation that they are seeking an overexpenditure for.

In the letter to the Controller, staff will specify that the overexpenditure will be from General Fund and the identified line item project will include an expansion of scope to provide for this

request. For the supplemental bill to be prepared for the Committee in January, staff will recommend creating a separate line item for this project at that time and include funding from the Capital Construction Fund and a transfer from the General Fund to the Capital Construction Fund."

COMMITTEE ACTION: Staff recommended, and the JBC approved, the interim supplemental request for FY 2021-22 in September 2021. Staff will include this item in the supplemental bill.
