Bill Summary

The bill requires that on and after January 1, 2017, the state controller make available for inclusion in the Colorado transparency online project (TOP) system demographic data about certain government contracts in Colorado.

1 *Be it enacted by the General Assembly of the State of Colorado:* 2 SECTION 1. Short title. The short title of this act is the 3 "Community Reinvestment Act". 4 **SECTION 2.** In Colorado Revised Statutes, add 24-72.4-106 as 5 follows: 6 24-72.4-106. Minority and women participation statistics -7 government contracts - web-based system - inclusion - definition. IN 8 ADDITION TO THE FINANCIAL INFORMATION REQUIRED BY THIS ARTICLE, 9 ON AND AFTER JANUARY 1, 2017, THE STATE CONTROLLER SHALL MAKE 10 AVAILABLE FOR INCLUSION IN THE WEB-BASED SYSTEM DATA ON THE 11 NUMBER OF LOCAL BUSINESSES, MINORITIES, BASED ON CATEGORIES 12 CONTAINED IN THE MOST RECENT UNITED STATES CENSUS, AND WOMEN 13 WHO PARTICIPATE AS GENERAL CONTRACTORS, SUBCONTRACTORS, AND 14 INDIVIDUALS HIRED FOR GOVERNMENT CONTRACTS ENTERED INTO BY 15 GOVERNMENTAL ENTITIES IN COLORADO. AS USED IN THIS SECTION, 16 "GOVERNMENTAL ENTITY" MEANS THE STATE, A COUNTY, A CITY AND 17 COUNTY, OR A CITY IN COLORADO. 18 **SECTION 3.** Safety clause. The general assembly hereby finds,

determines, and declares that this act is necessary for the immediatepreservation of the public peace, health, and safety.
