A BILL FOR AN ACT

101 CONCERNING AUTHORIZING SCHOOL DISTRICTS TO PURCHASE CRIME  
102 INSURANCE COVERAGE IN LIEU OF SURETY BONDS.

Bill Summary

Current law requires the secretary, assistant secretary, treasurer, and assistant treasurer of a school board and any person authorized by the board to be the custodian of money of the school district to obtain a surety bond before taking office. Additionally, a school board is required to obtain and pay for a surety bond for any person who is likely to have custody of \$50 or more of school district money.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, 22-32-104, **amend**  
3 (4) (b) and (4) (c); and **add** (4) (d) as follows:

4 **22-32-104. Organization of board of education.** (4) (b) EXCEPT  
5 AS PROVIDED IN PARAGRAPH (d) OF THIS SUBSECTION (4), no person shall  
6 enter upon the office of secretary or treasurer, or assistant secretary or  
7 assistant treasurer if there ~~be~~ ARE such offices, until he OR SHE has given  
8 a surety bond, in form satisfactory to the board, in the amount of five  
9 thousand dollars, conditioned upon the faithful performance of his OR HER  
10 duties as required by law and prescribed by the bylaws of the board of  
11 education. In addition, EXCEPT AS PROVIDED IN PARAGRAPH (d) OF THIS  
12 SUBSECTION (4), the treasurer, and the assistant treasurer if there ~~be~~ such  
13 office, shall give bond in such further amount, in such form, and for such  
14 purposes as the board may require.

15 (c) The board may also appoint and authorize any other person to  
16 act as custodian of moneys belonging to the district. EXCEPT AS PROVIDED  
17 IN PARAGRAPH (d) OF THIS SUBSECTION (4), such person shall give surety  
18 bonds, in such amount and form and for such purposes as the board may  
19 require.

20 (d) IN LIEU OF THE BONDS REQUIRED BY PARAGRAPHS (b) AND (c)  
21 OF THIS SUBSECTION (4), A SCHOOL DISTRICT MAY PURCHASE CRIME  
22 INSURANCE COVERAGE ON BEHALF OF THE OFFICERS AND EMPLOYEES TO  
23 PROTECT THE SCHOOL DISTRICT FROM ANY MALFEASANCE ON THE PART OF  
24 THE OFFICER WHILE IN OFFICE OR EMPLOYEES.

25 **SECTION 2.** In Colorado Revised Statutes, 22-32-109, **amend**

1 (1) (h) as follows:

2 **22-32-109. Board of education - specific duties.** (1) In addition  
3 to any other duty required to be performed by law, each board of  
4 education shall have and perform the following specific duties:

5 (h) To require each employee who is likely to have in his OR HER  
6 temporary custody at any one time an amount of school district moneys  
7 in excess of fifty dollars to be bonded in an amount at least sufficient to  
8 cover the amount of school district moneys which is likely to be in his OR  
9 HER temporary custody at any time, or to be bonded in such greater  
10 amount as the board may determine. A blanket form of surety bond may  
11 be utilized to cover more than one such employee. The district shall pay  
12 the costs for any such bonds. IN LIEU OF THE BONDS REQUIRED BY THIS  
13 PARAGRAPH (h), THE DISTRICT MAY PURCHASE CRIME INSURANCE  
14 COVERAGE TO PROTECT THE DISTRICT FROM ANY MALFEASANCE ON THE  
15 PART OF SUCH EMPLOYEE.

16 **SECTION 3. Safety clause.** The general assembly hereby finds,  
17 determines, and declares that this act is necessary for the immediate  
18 preservation of the public peace, health, and safety.
