A BILL FOR AN ACT

101 **CONCERNING THE ABILITY OF THE DEPARTMENT OF REVENUE TO**
102 **ALLOW ADDITIONAL APPLICATION METHODS FOR**
103 **IDENTIFICATION CARDS.**

Bill Summary

Beginning March 1, 2017, the bill allows anyone who holds a valid Colorado driver's license or whose Colorado driver's license has been expired for less than one year to apply by mail or electronically to the department of revenue for an identification card. Upon issuance of the identification card, the person's driver's license is cancelled.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, 42-2-302, **add** (9) as
3 follows:

4 **42-2-302. Department may or shall issue - limitations - rules**
5 **- repeal.** (9) (a) IN ACCORDANCE WITH RULES PROMULGATED BY THE
6 DEPARTMENT AND UPON THE APPLICANT'S SUBMISSION, EITHER
7 ELECTRONICALLY OR BY MAIL, OF AN APPLICATION AND PAYMENT OF THE
8 REQUIRED FEE, THE DEPARTMENT MAY ISSUE AN IDENTIFICATION CARD TO
9 THE HOLDER OF A DRIVER'S LICENSE ISSUED UNDER SECTION 42-2-114 OR
10 RENEWED UNDER 42-2-118 IF THE APPLICANT HOLDS A VALID LICENSE OR
11 IF NO MORE THAN ONE YEAR HAS PASSED SINCE THE EXPIRATION OF THE
12 APPLICANT'S DRIVER'S LICENSE.

13 (b) ONCE THE DEPARTMENT ISSUES AN IDENTIFICATION CARD
14 UNDER THIS SUBSECTION (9), THE DEPARTMENT SHALL CANCEL ANY VALID
15 DRIVER'S LICENSE HELD BY THE APPLICANT.

16 (c) THIS SECTION (9) TAKES EFFECT ON MARCH 1, 2017. THIS
17 PARAGRAPH (c) IS REPEALED, EFFECTIVE JULY 1, 2017.

18 **SECTION 2. Act subject to petition - effective date.** This act
19 takes effect at 12:01 a.m. on the day following the expiration of the
20 ninety-day period after final adjournment of the general assembly (August
21 10, 2016, if adjournment sine die is on May 11, 2016); except that, if a
22 referendum petition is filed pursuant to section 1 (3) of article V of the
23 state constitution against this act or an item, section, or part of this act
24 within such period, then the act, item, section, or part will not take effect
25 unless approved by the people at the general election to be held in

- 1 November 2016 and, in such case, will take effect on the date of the
- 2 official declaration of the vote thereon by the governor.
