### A BILL FOR AN ACT

#### 101 CONCERNING EXEMPTING MULTI-SERVING LIQUID RETAIL MARIJUANA

102 PRODUCTS FROM THE SALES EQUIVALENCY LIMITATION.

#### **Bill Summary**

The bill exempts a multi-serving liquid retail marijuana product from the limit on equivalency sales if the product complies with all statutory and rule requirements regarding packaging and it:

Is packaged in a structure that uses a single mechanism to achieve both child-resistance and accurate pouring dosing of each liquid serving in increments equal to or less than 10

1 Be it enacted by the General Assembly of the State of Colorado:

- 2 SECTION 1. In Colorado Revised Statutes, 12-43.4-402, add (3)
- 3 (a) (II.5) as follows:

4 Retail marijuana store license - definitions. 12-43.4-402. 5 (3) (a) (II.5) THE EQUIVALENCY RESTRICTIONS DESCRIBED IN 6 SUBPARAGRAPHS (I) AND (II) OF THIS PARAGRAPH (a) DO NOT APPLY TO A 7 MULTI-SERVING LIQUID RETAIL MARIJUANA PRODUCT, WHICH IS 8 IMPRACTICABLE TO MARK, IF THE PRODUCT COMPLIES WITH ALL 9 STATUTORY AND RULE PACKAGING REQUIREMENTS FOR MULTI-SERVING 10 EDIBLES AND COMPLIES WITH THE FOLLOWING ENHANCED REQUIREMENTS 11 TO REDUCE THE RISK OF ACCIDENTAL INGESTION. A MULTI-SERVING LIQUID 12 MUST:

13 (A) BE PACKAGED IN A STRUCTURE THAT USES A SINGLE
14 MECHANISM TO ACHIEVE BOTH CHILD-RESISTANCE AND ACCURATE
15 POURING DOSING OF EACH LIQUID SERVING IN INCREMENTS EQUAL TO OR
16 LESS THAN TEN MILLIGRAMS PER SERVING, WITH NO MORE THAN ONE
17 HUNDRED MILLIGRAMS TOTAL PER PACKAGE; AND

18 (B) THE DOSING COMPONENT IS WITHIN THE CHILD-RESISTANT CAP
19 OR CLOSURE OF THE BOTTLE AND IS NOT A SEPARATE COMPONENT.

SECTION 2. Safety clause. The general assembly hereby finds,
 determines, and declares that this act is necessary for the immediate
 preservation of the public peace, health, and safety.
