**A BILL FOR AN ACT**

101 **CONCERNING THE DUTIES OF THE SAFE2TELL PROGRAM, AND, IN**  
102 **CONNECTION THEREWITH, MAKING AN APPROPRIATION.**

**Bill Summary**

Under current law, the safe2tell program (safe2tell) provides awareness and education materials to all participating schools and school districts. The bill requires safe2tell to provide the materials to all preschool, elementary, and secondary schools in the state at no cost to the schools. The bill also requires safe2tell to provide the materials to the Boys & Girls Clubs and 4-H extension offices in Colorado at no charge.

The bill requires safe2tell to develop training curriculum and teaching materials for a train the trainer program and annually organize, host, and conduct trainings in all geographic regions of the state and provide related materials to persons who attend the training at no charge.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, 24-31-606, **amend**  
3 (2) (f) and (2) (g); and **add** (2) (h), (2) (i), and (2) (j) as follows:

4 **24-31-606. Safe2tell program - creation - duties.** (2) The  
5 program must:

6 (f) Train law enforcement dispatch centers, school districts,  
7 individual schools, and other entities determined by the attorney general  
8 on appropriate awareness and response to safe2tell tips; ~~and~~

9 (g) Provide safe2tell awareness and education materials to  
10 ~~participating schools and school districts~~ ALL PRESCHOOL, ELEMENTARY,  
11 AND SECONDARY SCHOOLS IN COLORADO AT NO CHARGE TO THE SCHOOL  
12 ON OR BEFORE JUNE 30, 2017, AND ANNUALLY EACH FISCAL YEAR  
13 THEREAFTER;

14 (h) PROVIDE SAFE2TELL AWARENESS AND EDUCATION MATERIALS  
15 TO BOYS & GIRLS CLUBS AND 4-H EXTENSION OFFICES IN COLORADO AT  
16 NO CHARGE TO THE BOYS & GIRLS CLUBS AND 4-H EXTENSION OFFICES ON  
17 OR BEFORE JUNE 30, 2017, AND ANNUALLY EACH FISCAL YEAR  
18 THEREAFTER;

19 (i) DEVELOP TRAINING CURRICULUM AND TEACHING MATERIALS  
20 FOR A TRAIN THE TRAINER PROGRAM; AND

21 (j) ANNUALLY ORGANIZE, HOST, AND CONDUCT TRAINING IN ALL  
22 GEOGRAPHIC REGIONS OF THE STATE AND PROVIDE RELATED MATERIALS  
23 TO PERSONS WHO ATTEND THE TRAINING AT NO CHARGE TO THE

1 ATTENDEE.

2 **SECTION 2. Appropriation.** For the 2016-17 state fiscal year,  
3 \$135,942 is appropriated to the department of law for use by the office of  
4 community engagement. This appropriation is from the general fund and  
5 is based on an assumption that the department will require an additional  
6 1.0 FTE. The office may use this appropriation to implement this act.

7 **SECTION 3. Safety clause.** The general assembly hereby finds,  
8 determines, and declares that this act is necessary for the immediate  
9 preservation of the public peace, health, and safety.
