HOUSE JOINT RESOLUTION 16-1017
CONCERNING THE DESIGNATION OF APRIL 12, 2016, AS "EQUAL PAY
DAY" IN COLORADO, AND, IN CONNECTION THEREWITH,
ACKNOWLEDGING THE PERSISTING PROBLEM OF WAGE
DISPARITY AMONG VARIOUS GROUPS.
WHEREAS, Fifty-three years after the passage of the "Equal Pay
Act of 1963" and Title VII of the "Civil Rights Act", women, and
particularly women of color, continue to suffer the consequences of being
paid less than men for doing the same work; and
WHEREAS, According to a report released by the Women's
Foundation of Colorado and the Institute for Women's Policy Research,
in 2013, Colorado women earned just 80 cents on the dollar compared
with their male counterparts; and

1 2 3	WHEREAS, Based on its 2015 research, the Institute for Women's Policy Research estimated that women won't receive equal pay until 2057 if progress continues at the same rate it has since 1960; and
4 5	WHEREAS, The wage gap is not only discernible by sex but also by race and ethnicity; and
6 7 8 9 10	WHEREAS, When comparing the earnings of women of each racial and ethnic group with the earnings of white men, white women in Colorado face the smallest gap, followed by Asian/Pacific Islander women at 70.5%, African American women at 65.5%, Native American women at 55.7%, and Latina women at only 53.8%; and
11 12 13 14 15	WHEREAS, As women age, the pay gap widens significantly: According to the American Association of University Women, one year after graduating college, women earn only 82% of what their male counterparts earn, but ten years after graduation, women earn only 75-80% of what men earn; and
16 17	WHEREAS, Over a working lifetime, the average woman will lose over \$700,000 to the wage gap; and
18 19 20	WHEREAS, Equal pay policies can be implemented simply and without undue costs or hardship in both the public and private sectors; and
21 22	WHEREAS, There exists a strong business and public interest case for equal pay for equal work; and
23 24 25 26	WHEREAS, Closing the pay gap between men and women strengthens the security of families today and eases future retirement costs while enhancing the American economy by circulating an additional \$450 billion from increased wages; and
27 28	WHEREAS, Equal pay would cut the poverty rate for working women in half, lifting almost 3 million women out of poverty; and
29 30 31	WHEREAS, Tuesday, April 12, 2016, symbolizes the time in the new year in which the wages paid to American women catch up to the wages paid to men from the previous year; now, therefore,

5 6 7 8	(2) Urge governmental agencies, nonprofit and labor organizations, businesses, and individuals to take steps to implement equal pay policies to help close the pay gap for Colorado's women and minorities.
