PREPARE FISCAL NOTES FOR THOSE BILLS.
Be It Resolved by the House of Representatives of the Seventieth General Assembly of the State of Colorado, the Senate concurring herein:
That in the Joint Rules of the Senate and the House of
Representatives, Joint Rule No. 24A, amend (d) introductory portion, and
(d) (I) (A); and add (d) (2.5), (d) (2.6), and (d) (2.7) as follows:
