102 HOUSE OF REPRESENTATIVES TO ESTABLISH REQUIREMENTS  
103 FOR INTERIM COMMITTEES THAT RELATE TO THE PROCESS FOR  
104 REQUESTING AND APPROVING BILLS IN ORDER TO TIMELY  
105 PREPARE FISCAL NOTES FOR THOSE BILLS.

1 *Be It Resolved by the House of Representatives of the Seventieth*  
2 *General Assembly of the State of Colorado, the Senate concurring herein:*

3 That in the Joint Rules of the Senate and the House of  
4 Representatives, Joint Rule No. 24A, **amend** (d) introductory portion, and  
5 (d) (I) (A); and **add** (d) (2.5), (d) (2.6), and (d) (2.7) as follows:

6 **24A. Interim Committee Requirements - Creation - Deadlines -**

2 (d) ~~Unless otherwise specified~~ The following ~~shall apply~~ APPLIES to  
3 interim committees:

4 (1) (A) WHEN THE REQUEST TO CREATE AN INTERIM  
5 COMMITTEE ORIGINATES IN THE HOUSE OF  
6 REPRESENTATIVES, BY JUNE 1, THE SPEAKER OF THE  
7 HOUSE OF REPRESENTATIVES SHALL APPOINT the  
8 ~~chairman shall be appointed by the Speaker of the~~  
9 ~~House of Representatives when the request to create~~  
10 ~~an interim committee originates in the House~~ CHAIR  
11 OF THE INTERIM COMMITTEE and the President of the

35 (B) THAT INTERIM COMMITTEE MEMBERS MUST SUBMIT

1 THE INTERIM COMMITTEE APPROVES SUCH  
2 REQUESTED BILLS OR, IF DRAFTING INFORMATION IS  
3 NOT AVAILABLE AT THE MEETING, TO THE OFFICE OF  
4 LEGISLATIVE LEGAL SERVICES WITHIN THREE  
5 CALENDAR DAYS AFTER THE MEETING;

6 (C) THAT, UPON NOTIFICATION TO THE CHAIR AND  
7 INTERIM COMMITTEE BY THE RESEARCH DIRECTOR OF  
8 LEGISLATIVE COUNCIL AND THE DIRECTOR OF THE  
9 OFFICE OF LEGISLATIVE LEGAL SERVICES, A BILL  
10 REQUEST IS DEEMED WITHDRAWN AND WILL NOT BE  
11 DRAFTED IF THE DRAFTING INFORMATION IS NOT  
12 MADE AVAILABLE IN ACCORDANCE WITH  
13 SUBPARAGRAPH (B) OF THIS PARAGRAPH (2.6);

14 (D) THE LAST DATE BY WHICH INTERIM COMMITTEE  
15 MEMBERS MUST FINALIZE BILL DRAFTS OR THAT BILL  
16 DRAFTS WILL BE DEEMED FINALIZED FOR  
17 DISTRIBUTION TO THE INTERIM COMMITTEE AND  
18 RELEASE TO THE LEGISLATIVE COUNCIL STAFF FOR  
19 PURPOSES OF PREPARING FISCAL NOTES ON  
20 PROPOSED BILL DRAFTS;

21 (E) THE LAST DATE FOR A MEETING AT WHICH THE  
22 INTERIM COMMITTEE WILL CONSIDER AND TAKE  
23 FINAL ACTION ON BILL DRAFTS.

24 (2.7) EACH INTERIM COMMITTEE SHALL ADHERE TO THE  
25 FOLLOWING PROCEDURES FOR MAKING BILL REQUESTS:

26 (A) BILLS MUST BE REQUESTED DURING A SINGLE  
27 INTERIM COMMITTEE MEETING SET FOR REQUESTING  
28 LEGISLATION AND MUST BE APPROVED BY A  
29 MAJORITY OF THE LEGISLATIVE COMMITTEE  
30 MEMBERS. THE OFFICE OF LEGISLATIVE LEGAL  
31 SERVICES WILL ONLY DRAFT BILLS THAT ARE  
32 REQUESTED AND APPROVED IN ACCORDANCE WITH  
33 THIS SUBPARAGRAPH (A);

34 (B) ONLY LEGISLATIVE MEMBERS OF THE INTERIM  
35 COMMITTEE MAY REQUEST AND VOTE TO APPROVE  
36 BILLS AND AMENDMENTS;

(C) WHEN A BILL DRAFT IS FINALIZED PURSUANT TO SUBPARAGRAPH (D) OF PARAGRAPH (2.6) OF THIS SUBSECTION (d), THE LEGISLATIVE COUNCIL STAFF IS AUTHORIZED TO SHARE THE FINALIZED BILL DRAFT WITH AFFECTED STATE AGENCIES FOR FISCAL NOTE PREPARATION PURPOSES; AND

(D) WHEN A BILL DRAFT IS FINALIZED PURSUANT TO SUBPARAGRAPH (D) OF PARAGRAPH (2.6) OF THIS SUBSECTION (d), NEITHER THE INTERIM COMMITTEE MEMBER WHO REQUESTED THE APPROVED BILL REQUEST NOR ANY OTHER INTERIM COMMITTEE MEMBER MAY MODIFY THE FINALIZED BILL DRAFT, AND INTERIM COMMITTEE MEMBERS MUST PRESENT ANY PROPOSED CHANGES TO THE FINALIZED BILL DRAFT AS AN AMENDMENT TO THE FINALIZED BILL DRAFT AT THE INTERIM COMMITTEE MEETING AT WHICH THE FINALIZED BILL DRAFT IS CONSIDERED.
