After consideration on the merits, the Committee recommends the following:

HB16-1047 be amended as follows, and as so amended, be referred to the Committee on Finance with favorable recommendation:

1 Amend printed bill, page 11, line 6, strike "FOR" and substitute "OR".

2 Page 30, after line 3 insert:

3 "SECTION 2. In Colorado Revised Statutes, 12-36-104, **add** (4)  
4 as follows:

5 **12-36-104. Powers and duties of board.** (4) TO FACILITATE THE  
6 LICENSURE OF A PHYSICIAN UNDER THE "INTERSTATE MEDICAL LICENSURE  
7 COMPACT ACT", PART 36 OF ARTICLE 60 OF TITLE 24, C.R.S., THE BOARD  
8 SHALL OBTAIN A SET OF FINGERPRINTS FROM AN APPLICANT FOR  
9 LICENSURE UNDER THE COMPACT AND SHALL FORWARD THE FINGERPRINTS  
10 TO THE COLORADO BUREAU OF INVESTIGATION FOR THE PURPOSE OF  
11 OBTAINING A FINGERPRINT-BASED CRIMINAL HISTORY RECORD CHECK.  
12 UPON RECEIPT OF FINGERPRINTS AND PAYMENT FOR THE COSTS, THE  
13 COLORADO BUREAU OF INVESTIGATION SHALL CONDUCT A STATE AND  
14 NATIONAL FINGERPRINT-BASED CRIMINAL HISTORY RECORD CHECK USING  
15 RECORDS OF THE COLORADO BUREAU OF INVESTIGATION AND THE  
16 FEDERAL BUREAU OF INVESTIGATION. THE BOARD IS THE AUTHORIZED  
17 AGENCY TO RECEIVE INFORMATION REGARDING THE RESULT OF A  
18 NATIONAL CRIMINAL HISTORY RECORD CHECK. THE APPLICANT WHOSE  
19 FINGERPRINTS ARE CHECKED SHALL PAY THE ACTUAL COSTS OF THE STATE  
20 AND NATIONAL FINGERPRINT-BASED CRIMINAL HISTORY RECORD CHECK.

21 **SECTION 3.** In Colorado Revised Statutes, 24-34-110, **amend**  
22 (3) (a) (VIII) as follows:

1           **24-34-110. Medical transparency act of 2010 - disclosure of**  
2 **information about health care licensees - fines - rules - short title -**  
3 **legislative declaration.** (3) (a) As used in this section, "applicant" means  
4 a person applying for a new, active license, certification, or registration  
5 or to renew, reinstate, or reactivate an active license, certification, or  
6 registration to practice:  
7           (VIII) Medicine pursuant to article 36 of title 12, C.R.S., OR PART  
8 36 OF ARTICLE 60 OF THIS TITLE;".  
9           Renumber succeeding section accordingly.
