After consideration on the merits, the Committee recommends the following:

HB16-1328 be amended as follows, and as so amended, be referred to the Committee of the Whole with favorable recommendation:

- 1 Amend reengrossed bill, page 11, strike lines 18 through 22 and
- 2 substitute:
- 3       "(4) (a) ON OR BEFORE JANUARY 1, 2017, AND ON OR BEFORE JULY
- 4 1, 2017, AND EVERY JANUARY 1 AND JULY 1 THEREAFTER, THE DIVISION
- 5 OF YOUTH CORRECTIONS SHALL REPORT ON ITS USE OF SECLUSION IN ANY
- 6 SECURE STATE-OPERATED OR STATE-OWNED FACILITY TO THE".
  
- 7 Page 11, line 24, strike "BIANNUAL".
  
- 8 Page 11, line 25, strike "BIANNUAL".
  
- 9 Page 12, strike lines 24 through 27.
  
- 10 Page 13, strike lines 1 through 12.
  
- 11 Page 13, strike lines 17 through 25 and substitute:
- 12       "(6) PRIOR TO JANUARY 1, 2018, THE DIVISION OF YOUTH
- 13 CORRECTIONS SHALL MEET THE REQUIREMENTS OF THIS SECTION TO THE
- 14 EXTENT THAT IT IS ABLE USING ITS CURRENT REPORTING MECHANISMS.
- 15 THE DIVISION OF YOUTH CORRECTIONS SHALL FULLY COMPLY WITH ALL
- 16 REQUIREMENTS OF THIS SECTION ON OR BEFORE JANUARY 1, 2018.".
  
- 17 Page 16, lines 3 and 4, strike "PURPOSES AND, IF NECESSARY," and

1 substitute "PURPOSES. THE DIVISION OF YOUTH CORRECTIONS SHALL  
2 SHARE WITH THE WORKING GROUP, ON AN ONGOING BASIS, AVAILABLE  
3 DATA REGARDING TIME SPENT IN CONFINEMENT BY YOUTH FOR  
4 ADMINISTRATIVE REASONS, AS DESCRIBED IN SECTION 26-20-104.5 (3), IN  
5 ANY SECURE STATE-OPERATED AND STATE-OWNED FACILITY. IF  
6 NECESSARY, THE WORKING GROUP MAY".

7 Page 16, line 8, strike "LIMITING".

8 Page 16, line 10, strike "BIANNUAL" and substitute "SEMIANNUAL".

9 Page 16, line 19, strike "BIANNUAL" and substitute "SEMIANNUAL".
