After consideration on the merits, the Committee recommends the following:

SB16-200 be amended as follows, and as so amended, be referred to the Committee on Appropriations with favorable recommendation:

1 Amend printed bill, page 2, line 9, after the period add "IN ORDER TO
2 REDUCE THE COSTS ASSOCIATED WITH CREATING THE WATER PROJECT
3 PERMITTING POSITION, NOTHING IN THIS SECTION PRECLUDES THE PERSON
4 NAMED TO THE POSITION ESTABLISHED UNDER PARAGRAPH (a) OF THIS
5 SUBSECTION (1) OF THIS SECTION FROM HOLDING OTHER TITLES OR
6 PERFORMING OTHER FUNCTIONS WITHIN THE GOVERNOR'S OFFICE."

7 Page 3, after line 16 insert:

8 "(4) NOTHING IN THIS SECTION EITHER GRANTS ANY JURISDICTION
9 TO THE DIRECTOR OVER ANY FEDERAL, STATE, OR LOCAL GOVERNMENT,
10 OR CURTAILS THE JURISDICTION OF ANY FEDERAL, STATE, OR LOCAL
11 GOVERNMENT TO FULFILL ITS STATUTORY RESPONSIBILITIES."

12 Page 3, line 21, after "(d)" insert "(I)".

13 Page 3, line 22, strike "___ DOLLARS" and substitute "AN AMOUNT OF
14 MONEY EQUAL TO ONE-HALF OF THE INDIRECT AND DIRECT COSTS OF THE
15 DIRECTOR OF WATER PROJECT PERMITTING TO IMPLEMENT SECTION
16 24-20-114, C.R.S., OR SO MUCH THEREOF THAT IS AVAILABLE,".

17 Page 3, after line 27 insert:

1 "(II) THE DIVISION SHALL ASSESS A PRORATED FEE FOR EACH OF
2 THE FOUR TIERS SPECIFIED IN THIS SUBSECTION (1.2) TO GENERATE AN
3 AMOUNT OF MONEY EQUAL TO ONE-HALF OF THE INDIRECT AND DIRECT
4 COSTS OF THE DIRECTOR OF WATER PROJECT PERMITTING TO IMPLEMENT
5 SECTION 24-20-114, C.R.S. THE DIRECTOR SHALL DETERMINE THE
6 AMOUNTS OF THE FEES AND ANNUALLY NOTIFY THE DIVISION OF THE
7 AMOUNTS."

8 Page 4, line 7, strike "___ DOLLARS" and substitute "AN AMOUNT OF
9 MONEY EQUAL TO ONE-HALF OF THE INDIRECT AND DIRECT COSTS OF THE
10 DIRECTOR OF WATER PROJECT PERMITTING TO IMPLEMENT SECTION
11 24-20-114, C.R.S., OR SO MUCH THEREOF THAT IS AVAILABLE,".
