**A BILL FOR AN ACT**

101 **CONCERNING LEGALIZING CERTAIN KNIVES.**

**Bill Summary**

The bill legalizes the possession of a gravity knife or switchblade knife by removing such knives from the definition of "illegal weapon".

2 **SECTION 1.** In Colorado Revised Statutes, 18-12-101, **amend**

1 (1) introductory portion; and **repeal** (1)(e) and (1)(j) as follows:

2 **18-12-101. Definitions - peace officer affirmative defense.**

3 (1) As used in this ~~article~~ ARTICLE 12, unless the context otherwise  
4 requires:

5 (e) ~~"Gravity knife" means any knife that has a blade released from  
6 the handle or sheath thereof by the force of gravity or the application of  
7 centrifugal force.~~

8 (j) ~~"Switchblade knife" means any knife, the blade of which opens  
9 automatically by hand pressure applied to a button, spring, or other device  
10 in its handle.~~

11 **SECTION 2.** In Colorado Revised Statutes, 18-12-102, **amend**  
12 (2) as follows:

13 **18-12-102. Possessing a dangerous or illegal weapon -**  
14 **affirmative defense.** (2) As used in this section, the term "illegal  
15 weapon" means a blackjack, gas gun, OR metallic knuckles. ~~gravity knife,~~  
16 ~~or switchblade knife.~~

17 **SECTION 3. Act subject to petition - effective date.** This act  
18 takes effect at 12:01 a.m. on the day following the expiration of the  
19 ninety-day period after final adjournment of the general assembly (August  
20 9, 2017, if adjournment sine die is on May 10, 2017); except that, if a  
21 referendum petition is filed pursuant to section 1 (3) of article V of the  
22 state constitution against this act or an item, section, or part of this act  
23 within such period, then the act, item, section, or part will not take effect  
24 unless approved by the people at the general election to be held in  
25 November 2018 and, in such case, will take effect on the date of the  
26 official declaration of the vote thereon by the governor.
