A BILL FOR AN ACT

101 **CONCERNING EXTENSION OF THE PERIOD FOLLOWING THE**
102 **DECLARATION BY THE GOVERNOR OF A DISASTER EMERGENCY**
103 **IN A COUNTY WITHIN WHICH THE BOARD OF COUNTY**
104 **COMMISSIONERS OF THE COUNTY MAY TRANSFER COUNTY**
105 **GENERAL FUND MONEY TO THE COUNTY ROAD AND BRIDGE FUND**
106 **FOR THE PURPOSES OF DISASTER RESPONSE AND RECOVERY.**

declaration by the governor of a disaster emergency in a county within which the board of county commissioners of the county may transfer county general fund money to the county road and bridge fund for the purposes of disaster response and recovery.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, 30-25-106, **amend**
3 (3) as follows:

4 **30-25-106. Fund - purposes.** (3) Notwithstanding the provisions
5 of subsection (1) of this section, the board of county commissioners is
6 authorized to transfer money from the county general fund to the county
7 road and bridge fund created in section 43-2-202 ~~C.R.S.~~, if the governor
8 declares, by executive order or proclamation, a disaster emergency in the
9 applicable county pursuant to section 24-33.5-704 (4). ~~C.R.S.~~ The board
10 of county commissioners is authorized to make the transfers until ~~four~~
11 EIGHT years after the date of the governor's declaration of an emergency
12 in the county. Any county general fund money transferred into the county
13 road and bridge fund ~~shall~~ MUST be used for the purposes of disaster
14 response and recovery in a manner consistent with the permissible uses
15 of money in the county road and bridge fund.

16 **SECTION 2. Act subject to petition - effective date.** This act
17 takes effect at 12:01 a.m. on the day following the expiration of the
18 ninety-day period after final adjournment of the general assembly (August
19 9, 2017, if adjournment sine die is on May 10, 2017); except that, if a
20 referendum petition is filed pursuant to section 1 (3) of article V of the
21 state constitution against this act or an item, section, or part of this act
22 within such period, then the act, item, section, or part will not take effect
23 unless approved by the people at the general election to be held in

- 1 November 2018 and, in such case, will take effect on the date of the
- 2 official declaration of the vote thereon by the governor.
