A BILL FOR AN ACT

101 **CONCERNING HOW TO MEASURE THE LEVEL OF DELTA-9**
102 **TETRAHYDROCANNABINOL IN INDUSTRIAL HEMP.**

Bill Summary

The bill requires the commissioner of agriculture to determine the level of delta-9 tetrahydrocannabinol in industrial hemp by measuring the combined concentration of delta-9 tetrahydrocannabinol and tetrahydrocannabinolic acid.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, 35-61-105, **amend**
3 (2) as follows:

4 **35-61-105. Report of growth and sales activities - verification**
5 **of crop content - testing - waiver of concentration limits - rules.**

6 (2) The commissioner, in consultation with the committee, shall adopt
7 rules to establish an inspection program to determine delta-9
8 tetrahydrocannabinol levels and ensure compliance with the limits on
9 delta-9 tetrahydrocannabinol concentration. THE COMMISSIONER SHALL
10 DETERMINE THE DELTA-9 TETRAHYDROCANNABINOL CONCENTRATION BY
11 MEASURING THE COMBINED CONCENTRATION OF DELTA-9
12 TETRAHYDROCANNABINOL AND ITS PRECURSOR, DELTA-9
13 TETRAHYDROCANNABINOLIC ACID. The rules shall also establish a process
14 by which a registrant may apply to the commissioner for a waiver from
15 the delta-9 tetrahydrocannabinol concentration limits under circumstances
16 specified in the rules.

17 **SECTION 2. Act subject to petition - effective date.** This act
18 takes effect at 12:01 a.m. on the day following the expiration of the
19 ninety-day period after final adjournment of the general assembly (August
20 9, 2017, if adjournment sine die is on May 10, 2017); except that, if a
21 referendum petition is filed pursuant to section 1 (3) of article V of the
22 state constitution against this act or an item, section, or part of this act
23 within such period, then the act, item, section, or part will not take effect
24 unless approved by the people at the general election to be held in
25 November 2018 and, in such case, will take effect on the date of the
26 official declaration of the vote thereon by the governor.
