#### A BILL FOR AN ACT

101	CONCERNING THE AUTHORITY OF THE COLORADO DENTAL BOARD TO
102	PROMULGATE RULES BASED ON CLARIFICATIONS TO EXISTING
103	LAWS THAT RELATE TO COLLABORATIVE DENTAL AGREEMENTS.

### **Bill Summary**

(Note: This summary applies to this bill as introduced and does not reflect any amendments that may be subsequently adopted. The bill clarifies that the Colorado dental board may promulgate rules for the use of lasers for dental and dental hygiene purposes within the defined scopes of practice and with appropriate supervision. The bill makes clarifications as to what is considered the practice of unsupervised dental hygiene. The bill also corrects a statutory reference.

- varnish, and antimicrobial solutions for mouth rinsing, and other nonsystemic antimicrobial agents, AND RELATED EMERGENCY DRUGS AND REVERSAL AGENTS in collaboration with a licensed dentist. THE BOARD MAY, BY RULE, FURTHER DEFINE THE PERMISSIBLE AND APPROPRIATE EMERGENCY DRUGS AND REVERSAL AGENTS. Dental hygienists shall maintain clear documentation in the patient record of the DRUG OR agent prescribed, administered, or dispensed; the date of the action; and the rationale for prescribing, administering, or dispensing the DRUGOR agent.
  - (III) A dental hygienist may prescribe the following:

- (B) Topical anti-caries treatments as follows, all using sodium fluoride unless otherwise indicated: Toothpastes: 1.1 % or less (or stannous fluoride 0.4%); topical gels: 1.1% or less (or stannous fluoride 0.4%); oral rinses: 0.05%, 0.2%, 0.44%, or 0.5%; oral rinse concentrate used in periodontal disease: 0.63% stannous fluoride; fluoride varnish: 5%; and prophy pastes containing approximately 1.23% sodium fluoride and used for polishing procedures as part of professional dental prophylaxis treatment; and
- (C) Topical anti-infectives as follows: Chlorhexidine gluconate rinses: 0.12%; chlorhexidine gluconate periodontal chips for SUBGINGIVAL insertion into the A periodontal pocket/SULCUS; tetracycline impregnated fibers, inserted subgingivally into the A periodontal POCKET/sulcus; doxycycline hyclate periodontal gel, inserted subgingivally into the A periodontal POCKET/sulcus; and minocycline hydrochlorided periodontal paste POWDER, inserted subgingivally into the A periodontal POCKET/sulcus; AND
- (D) RELATED EMERGENCY DRUGS AND REVERSAL AGENTS AS AUTHORIZED BY THE COLLABORATING DENTIST.
