**Bill Summary**

House Bill 16-1309, which was enacted by the 2016 general assembly, concerned a defendant's right to counsel in certain cases considered by municipal courts. The bill delays the implementation of House Bill 16-1309 until July 1, 2018.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Session Laws of Colorado 2016, **amend** section  
3 4 of chapter 366 as follows:

4 Section 4. **Act subject to petition - effective date.** This act takes  
5 effect ~~May 1, 2017~~ JULY 1, 2018; except that, if a referendum petition is  
6 filed pursuant to section 1 (3) of article V of the state constitution against  
7 this act or an item, section, or part of this act within the ninety-day period  
8 after final adjournment of the general assembly, then the act, item,  
9 section, or part will not take effect unless approved by the people at the  
10 general election to be held in November 2016 and, in such case, will take  
11 effect on ~~May 1, 2017~~ JULY 1, 2018, or on the date of the official  
12 declaration of the vote thereon by the governor, whichever is later.

13 **SECTION 2. Amend** the amending clause of section 1 of  
14 HB 17-1083 as follows:

15 **SECTION 1.** In Colorado Revised Statutes, 16-7-207, **amend as**  
16 **it will become effective ~~May 1, 2017,~~ July 1, 2018,** (3) as follows:

17 **SECTION 3. Safety clause.** The general assembly hereby finds,  
18 determines, and declares that this act is necessary for the immediate  
19 preservation of the public peace, health, and safety.
