A BILL FOR AN ACT

101 **CONCERNING PROTECTING COLORADO CITIZENS WHO ARE ENGAGED**
102 **IN AN ACT THAT IS PROTECTED BY THE COLORADO**
103 **CONSTITUTION FROM OUTSIDE AGENCIES.**

The bill prohibits a state agency or agency of a state political subdivision from aiding or assisting a federal agency or agency of another state in:

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, **add** article 78.5 to
3 title 24 as follows:

4 **ARTICLE 78.5**

5 **Protect Colorado Constitutional Rights**

6 **24-78.5-101. Protecting Colorado constitutional rights -**
7 **definition.** (1) THE STATE OR A STATE AGENCY SHALL NOT KNOWINGLY
8 ASSIST OR AID:

9 (a) A FEDERAL AGENCY OR AGENCY OF ANOTHER STATE IN
10 ARRESTING A COLORADO CITIZEN FOR COMMITTING AN ACT THAT IS A
11 COLORADO CONSTITUTIONAL RIGHT; OR

12 (b) A FEDERAL AGENCY OR AGENCY OF ANOTHER STATE IN
13 VIOLATING A COLORADO CITIZEN'S COLORADO CONSTITUTIONAL RIGHT.

14 (2) FOR PURPOSES OF THIS SECTION, "COLORADO CONSTITUTIONAL
15 RIGHT" MEANS A RIGHT ENUMERATED IN THE COLORADO CONSTITUTION
16 THAT HAS NOT BEEN DECLARED UNCONSTITUTIONAL BY A FEDERAL OR
17 COLORADO APPELLATE COURT.

18 **SECTION 2. Safety clause.** The general assembly hereby finds,
19 determines, and declares that this act is necessary for the immediate
20 preservation of the public peace, health, and safety.
