A BILL FOR AN ACT

101 CONCERNING A REQUIREMENT FOR A TIMELY HEARING FOR A
102 DEFENDANT IN JAIL WITH A MUNICIPAL COURT HOLD.

Bill Summary

(Note: This summary applies to this bill as introduced and does not reflect any amendments that may be subsequently adopted. If this bill passes third reading in the house of introduction, a bill summary that applies to the reengrossed version of this bill will be available at http://leg.colorado.gov.)

If a person is detained in a jail on a municipal hold and does not immediately receive a personal recognizance bond, the jail shall promptly notify the municipal court of the hold or, if the municipal hold is the sole basis for the person's detention, notify the municipal court of the hold within 4 hours. Once a demanding municipal court receives the notice that its hold is the sole basis for the detention, the court shall transfer the

defendant for a hearing within 2 days of receiving the notice; except that if the defendant has failed to appear at least twice in the case and the jail is in a different county than the county where the municipality is located, the demanding municipal court shall transfer the defendant for a hearing within 4 days. At the hearing the municipal court must either:

- ! Arraign the defendant; or
- ! If the defendant is being held for failure to appear, conduct the proceedings related to the failure to appear unless the proceeding is a trial or evidentiary hearing or requires the presence of a witness.

If the case is not resolved at the hearing, the municipal court shall conduct a bond hearing and release the defendant on bond under the least restrictive conditions possible. If the defendant is not brought before the municipal court within the required time limits, the jail holding the defendant shall release the defendant on an unsecured personal recognizance bond with no other conditions returnable to the municipal court. A municipal court shall adopt standing orders to effectuate the defendant's release if the defendant is not transferred to the municipal court within the required time frames.

Be it enacted by the General Assembly of the State of Colorado:

2 SECTION 1. Legislative declaration. The general assembly

5 **SECTION 2.** In Colorado Revised Statutes, **add** 13-10-111.5 as

8 (1) IF A PERSON IS DETAINED IN A JAIL ON A MUNICIPAL HOLD AND DOES

NOT IMMEDIATELY RECEIVE A PERSONAL RECOGNIZANCE BOND, THE JAIL

10 SHALL PROMPTLY NOTIFY THE MUNICIPAL COURT OF ANY MUNICIPAL

(4) IF THE DEFENDANT DOES NOT APPEAR BEFORE THE MUNICIPAL
COURT FOR A HEARING WITHIN THE TIME FRAMES REQUIRED BY
SUBSECTION (2) OF THIS SECTION, THE JAIL HOLDING THE DEFENDANT
SHALL RELEASE THE DEFENDANT ON AN UNSECURED PERSONAL
RECOGNIZANCE BOND WITH NO OTHER CONDITIONS RETURNABLE TO THE
MUNICIPAL COURT. THIS SUBSECTION (4) DOES NOT APPLY IF THE
DEFENDANT REFUSED TO COOPERATE WITH THE COURT'S ATTEMPTS TO
HOLD THE HEARING IN COMPLIANCE WITH SUBSECTION (2) OF THIS
SECTION.

(5) EACH MUNICIPAL COURT SHALL ADOPT STANDING ORDERS TO IMPLEMENT SUBSECTION (4) OF THIS SECTION AND SHALL PROVIDE THE ORDERS TO EACH JAIL IN THE COUNTY WHERE THE MUNICIPAL COURT IS LOCATED. IN EVERY ARREST WARRANT ISSUED BY A MUNICIPAL COURT, THE MUNICIPAL COURT SHALL ORDER THAT THE DEFENDANT BE RELEASED ON A PERSONAL RECOGNIZANCE BOND WITH NO OTHER CONDITIONS IF THE DEFENDANT DOES NOT APPEAR BEFORE THE MUNICIPAL COURT FOR A HEARING WITHIN THE TIME FRAMES REQUIRED BY SUBSECTION (2) OF THIS SECTION.

SECTION 3. Act subject to petition - effective date. This act takes effect January 1, 2018; except that, if a referendum petition is filed pursuant to section 1 (3) of article V of the state constitution against this act or an item, section, or part of this act within the ninety-day period after final adjournment of the general assembly, then the act, item, section, or part will not take effect unless approved by the people at the
