A BILL FOR AN ACT

101 **CONCERNING FUNDING SOURCES RELATED TO SERVICES FOR**
102 **BEHAVIORAL OR MENTAL HEALTH DISORDERS.**

Bill Summary

(Note: This summary applies to this bill as introduced and does not reflect any amendments that may be subsequently adopted. Joint Budget Committee. The bill clarifies that the authorized purposes for which the marijuana tax cash fund may be used include behavioral services.

The bill also repeals the offender mental health services fund, which no longer has a revenue source, and directs the remaining money in the fund to be transferred to the general fund.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, 39-28.8-501, **amend**
3 (2)(b)(IV) introductory portion, (2)(b)(IV)(C), and (2)(b)(IV)(D) as
4 follows:

5 **39-28.8-501. Marijuana tax cash fund - creation - distribution**
6 **- legislative declaration.** (2) (b) (IV) Subject to the limitation in
7 subsection (5) of this section, the general assembly may annually
8 appropriate any money in the fund for any fiscal year following the fiscal
9 year in which ~~they were~~ IT WAS received by the state for the following
10 purposes:

11 (C) To treat and provide related services to people with any type
12 of substance use OR BEHAVIORAL HEALTH disorder, including those with
13 co-occurring disorders, or to evaluate the effectiveness and sufficiency of
14 ~~substance use~~ BEHAVIORAL HEALTH disorder services;

15 (D) For jail-based and other behavioral health services for persons
16 involved in OR DIVERTED FROM the criminal justice system; ~~through the~~

19 **SECTION 2.** In Colorado Revised Statutes, 27-66-104, **amend**
20 (4) as follows:

21 **27-66-104. Types of services purchased - limitation on**
22 **payments - offender mental health services fund - repeal.** (4) (a) The
23 offender mental health services fund, referred to in this subsection (4) as
24 the "fund", is ~~hereby~~ created in the state treasury. On and after July 1,
25 2016, the principal of the fund consists of any money that the general
26 assembly may appropriate to the fund for the purchase of BEHAVIORAL OR

1 mental health DISORDER services for juvenile and adult offenders who
2 have BEHAVIORAL OR mental health ~~problems~~ DISORDERS and are
3 involved in the criminal justice system. Subject to annual appropriation
4 by the general assembly, the ~~unit~~ OFFICE OF BEHAVIORAL HEALTH shall
5 distribute the principal of the fund to the community mental health
6 centers. Any unexpended and unencumbered ~~moneys~~ MONEY in the fund
7 at the end of the 2015-16 fiscal year shall be transferred to the tobacco
8 litigation settlement cash fund created in section 24-22-115. ~~C.R.S.~~

9 (b) Repealed.

10 (c) THIS SUBSECTION (4) IS REPEALED, EFFECTIVE SEPTEMBER 1,
11 2017.

12 **SECTION 3. Safety clause.** The general assembly hereby finds,
13 determines, and declares that this act is necessary for the immediate
14 preservation of the public peace, health, and safety.
