After consideration on the merits, the Committee recommends the following:

HB17-1070 be amended as follows, and as so amended, be referred to the Committee on Appropriations with favorable recommendation:

- 1 Amend printed bill, page 4, line 7, after "24-33.5-1228," insert "**amend**
- 2 (3); and".
- 3 Page 4, line 12, strike "**rules - repeal.**" and substitute "**rules.**".
- 4 Page 4, strike lines 14 and 15 and substitute "SUBSECTION (2.5)(b) OF THIS
- 5 SECTION, UPON RECEIVING SUFFICIENT MONEY IN THE FORM OF GIFTS,
- 6 GRANTS, AND DONATIONS, THE CENTER OF EXCELLENCE SHALL CONDUCT
- 7 A".
- 8 Page 4, line 18, strike "PUBLIC SAFETY." and substitute "FIREFIGHTING.".
- 9 Page 4, line 21, strike "PUBLIC SAFETY," and substitute "FIREFIGHTING,".
- 10 Page 4, line 22, strike "FIREFIGHTING,".
- 11 Page 5, line 2, strike "ON OR BEFORE SEPTEMBER 1, 2018," and substitute
- 12 "NOT LATER THAN ONE MONTH AFTER COMPLETING THE STUDY DESCRIBED
- 13 IN SUBSECTION (2.5)(c)(I) OF THIS SECTION,".
- 14 Page 5, strike lines 11 through 14 and substitute:
- 15 "(d) (I) AS PART OF THE STUDY DESCRIBED IN SUBSECTION
- 16 (2.5)(c)(I) OF THIS SECTION, UPON RECEIVING SUFFICIENT MONEY IN THE
- 17 FORM OF GIFTS, GRANTS, AND DONATIONS, ON AND AFTER THE EFFECTIVE".

1 Page 5, line 19, strike "PUBLIC SAFETY." and substitute "FIREFIGHTING.".

2 Page 5, strike line 26 and substitute "FIREFIGHTING, INCLUDING BUT NOT
3 LIMITED TO SEARCH".

4 Page 6, strike lines 3 through 8.

5 Page 6, after line 8 insert:

6 "(3) (a) The division shall administer the Colorado firefighting air
7 corps fund, which fund is hereby created in the state treasury. The
8 division ~~is authorized to~~ MAY seek and accept gifts, grants,
9 reimbursements, investments, bond revenues, sales proceeds,
10 commissions for services, sponsorships, advertising fees, licensing fees,
11 profits, or donations from private or public sources for the purposes of
12 this section. The fund consists of all ~~moneys~~ MONEY that may be
13 appropriated to the fund by the general assembly, and all private and
14 public funds received through gifts, grants, reimbursements, investments,
15 bond revenues, sales proceeds, commissions for services, sponsorships,
16 advertising fees, licensing fees, profits, or donations that are transmitted
17 to the state treasurer and credited to the fund. All interest earned from the
18 investment of ~~moneys~~ MONEY in the fund ~~are~~ IS credited to the fund. The
19 ~~moneys~~ MONEY in the fund ~~are hereby~~ IS continuously appropriated for
20 the purposes indicated in ~~paragraph (c) of this subsection (3)~~ SUBSECTION
21 (3)(c) OF THIS SECTION. Any ~~moneys~~ MONEY not expended at the end of
22 the fiscal year ~~remain~~ REMAINS in the fund.

23 (b) The general assembly finds that the implementation of this
24 section does not rely entirely ~~or in any part~~ on the receipt of adequate
25 funding through gifts, grants, or donations. Therefore, the division is not
26 subject to the notice requirements specified in section 24-75-1303 (3).

27 (c) The division shall use the ~~moneys~~ MONEY in the Colorado
28 firefighting air corps fund for the PURPOSES OF SUBSECTION (2.5) OF THIS
29 SECTION AND FOR PAYING THE direct and indirect costs of maintaining the
30 Colorado firefighting air corps, including expenses associated with
31 acquisition, retrofitting, labor, equipment, supply, transportation, air,
32 mobilization, repair, maintenance, and demobilization."

33 Page 1, line 102, strike "PUBLIC SAFETY," and substitute
34 "FIREFIGHTING,".
