- 5 "EMPLOYER" DOES NOT INCLUDE A PERSON OR ENTITY THAT OFFERS
- 6 EMPLOYEES A QUALIFIED RETIREMENT PLAN AS SPECIFIED IN SUBSECTION
- 7 (3)(a)(III) OF THIS SECTION. "EMPLOYER" INCLUDES A PERSON OR ENTITY
- 8 THAT:".
- 9 Page 7, line 18, strike "PLAN," and substitute "PLAN TO ANY EMPLOYEES,".
- 10 Page 8, line 9, strike "ACCOUNT." and substitute "ACCOUNT, TO BE
- 11 DETERMINED BY THE BOARD.".
- Page 8, line 26, after "ESTABLISHED." insert "THIS PLAN IS NOT A DEFINED
- 13 BENEFIT PENSION PLAN.".
- 14 Page 11, line 23, strike "BENEFITS;" and substitute "BENEFITS AND
- 15 CONSIDERS THE TYPE OF IRA OFFERED AS A WAY OF INCREASING THE
- 16 PORTABILITY OF BENEFITS;".
- 17 Page 15, line 3, strike "PLAN;" and substitute "PLAN AND COMPLYING WITH

- BASED ON THE NUMBER OF AND NATURE OF THE VIOLATIONS;".
