- 4 SCHEDULED OR RESERVED ACTIVITIES IN THAT PORTION OR SECTION OF

- 8 Page 3, lines 18 and 19, strike "GENERAL OR APPROPRIATE DISTRICT
- 9 ATTORNEY; AND" and substitute "GENERAL; OR".
- Page 3, line 20, strike "STUDENT" and substitute "A MEMBER OF THE
- 11 COLLEGE OR UNIVERSITY COMMUNITY".
